Workgroup Updates

Data Governance (one-time)

Proposal:

- Each approved recovery school will have a school ID
- Each operator will be responsible for data management and collections
- ODE will have a recovery school district ID for all schools
- ODE will likely have some LEA-level reporting responsibilities

Things to solve:

- Identify which data collections apply to recovery schools (see worksheet)
- Planning a meeting with finance and accountability data teams for February or March

Satellite Campus Workgroup (ongoing)

Discussion:

- Primary Campus vs. Satellite Campus
- Satellite Campus requirements
- Permission to operate in other districts

Things to solve:

- Transportation
- Local partnership requirements
- Incubator model
- How much detail to require upfront and in contracts

- 13. Teacher Qualifications
- 14. Transportation
- 15. Special Education Students
- 16. Funding


