FINDINGS OF FACT

1. On October 20, 2017, Parent filed eight due process complaints pertaining to Student and the 2016-2017 schoolyear with the Oregon Department of Education (ODE). The ODE assigned each due process complaint a case number, DP 17-117 through DP 17-123 and DP 17-125, respectively. On October 23, 2017, the ODE referred cases DP 17-117 through DP 17-123 and DP 17-125 to the Office of Administrative Hearings (OAH) for due process hearings.
2. On October 24, 2017, Parent filed another due process complaint pertaining to Student and the 2016-2017 schoolyear. The ODE assigned the complaint case no. DP 17-126 and referred the hearing request to the OAH.
3. Parent requested separate due process hearings on each of the nine complaints. On October 24, 2017, the OAH denied Parent's request for separate hearings and notified Parent that pursuant to OAR 137-003-0525(1)(c), and for purposes of judicial efficiency and economy, Parent's due process complaints would be consolidated for hearing.
4. Via electronic mail on October 25, 2017, Parent withdrew the due process hearing

requests in case numbers DP 17-117 through DP 17-123, DP 17-125 and DP 17-126 without prejudice.

ORDER

Parent's nine requests for due process hearings in the above-captioned matters are withdrawn. The cases are dismissed without prejudice.
