FINDINGS OF FACT

(1) On April 2, 2018, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of M.A. (Student). The Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Jill Marie Messecar to preside over the hearing in this matter.

(2) On May 8, 2018, ALJ Messecar conducted a prehearing conference by telephone. Richard Cohn-Lee, attorney at law, appeared on behalf of the Hillsboro Public School District 1J (the District). Kevin Brague, attorneys at law, appeared for Parent. At the prehearing conference, the parties requested the 45-day deadline for issuing the Final Order be extended to a date certain. ALJ Messecar granted the request and scheduled the hearing for June 13th and 14th, 2018 with the order to be issued on or about August 17, 2018.

(3) On May 31, 2018, Mr. Brague notified the Office of Administrative Hearings that the issues under the due process complaint had been resolved and that the due process complaint should be dismissed.

ORDER

The April 2, 2018, request for a due process hearing has been withdrawn and the case is dismissed.
