12. **Description:** State regulation specifies that sheltered workshops are not part of the continuum of placements options or supplementary aids services.

13. **Description:** State requirements specify that a student ages 5 – 21 can only be found eligible as a student with autism if the disabilities have an adverse impact on educational performance.

14. **Description:** The Oregon Teacher Standards and Practices Commission, the State agency responsible for Oregon educator licensure, currently requires special educators to hold a special education endorsement and separate endorsements for each content area exclusively taught by the special educators. The scope of licensure is determined through Oregon's Course to Endorsement Catalog.

15. **Description:** State requires IEP teams to consider the impact of COVID-19 on the eligible student's ability to engage in their education, develop and re-establish social connections with peers and school personnel, and adapt to the structure of in-person learning; requires consideration of impact of COVID-19 during initial IEP meetings and annual review meetings. When the IEP team determines the need for recovery services, student IEPs will be updated to include individualized COVID recovery services.

16. **Description:** State has authority to monitor the implementation of activities required by IDEA. School districts and programs involved in the education of children or students with disabilities shall undertake activities of General Supervision as directed by the Department. Integrated monitoring and technical supports, dispute resolution processes, and timely correction of non-compliance are among the specific activities authorized to the State. There are timelines for correction on noncompliance that are more stringent than those required by the IDEA when the Department determines that the noncompliance could result in a significant denial of instruction.

## B. Significant Disproportionality
