What is this calendar for?

ODE has a state-contracted warehouse for dry/refrigerated and frozen products in Clackamas, OR, through Gold Star Foods, our current contractor. ODE delivers statewide up to twice per month except for November, December and March, which are each one ship period due to holiday breaks. May is the last delivery month and all remaining inventory will automatically be placed on May order.

How to release inventory?

Deliveries of USDA Foods to the state warehouse begin in July.

To release your USDA Foods items for delivery to your location after it arrives in the warehouse, you need to utilize Gold Star inventory release system. Log into Gold Star system and release your items for a desired delivery window as shown in this calendar, and place as many orders as you want until the cut-off date, 'order due date' outlined by the red squares. Minimum delivery is 20 cases per site (except for the last delivery period in May). Once your ship date is confirmed, Gold Star will notify you via e-mail.

Did you know?

WBSCM sends an 'Order Received' e-mail to all Recipient Agencies when USDA food has been physically received by the state warehouse. Within 1-3 business days, these items will be available for release in the Gold Star system and will appear as available inventory.

Recipient agencies are expected to release items as soon as they receive the notification email from WBSCM.

You will be allowed 90-day dwell/storage time from the date of receipt in the warehouse. Storage fees will apply after 90 days. ODE reserves the right to transfer entitlement or food to other agencies so that they can be fully utilized per Federal regulation.
