# Tribal History/Shared History (THSH)

SHARED HISTORY

- Request for Applications (RFA) in the process to hire a consultant to complete lesson plans with focus on K-3rd grade. Currently in Procurement and moving internally.
- Current Lesson Plans have been translated into Spanish, including all support materials, and are being uploaded onto our webpage. Materials are also offered in a google platform to accommodate schools not using Microsoft.
- All nine Oregon Tribes are receiving funds to continue developing place-based lesson plans.
   Creation of Tribal specific PD will also be allowed under the grant. Waiting assignment in Procurement and the IGAs will soon be sent to Tribes. Funds are now in EGMS.
- We will be creating a THSH Community of Practice (COP) to support educators effectively delivering our THSH lesson plans.
- The THSH webpage is under continuous update, so check back frequently.
- We will also be creating additional THSH professional development.

# Empowering Tribal Voices: Supporting Indigenous Languages Grant

#### **Tribal Language**

Empowering Tribal Voices: Supporting Indigenous Languages (Tribal language grants) have been placed with procurement and are expected to be available for execution by April 1st, 2024.

Biennium grant cycle: June 30, 2023 - June 30, 2025


- Amount per awardee: 200k per the biennium cycle
- Immediate amount available upon contract execution: 100k is available upon execution.

#### **★** Recent revival of ODE Tribal Language Advisory Community of Practice

- Currently the body is made up from the nine tribe's Tribal language directors and staff.
- Monthly one hour meetings at present as we work toward becoming a more formalized group to best uplift and elevate language efforts and supports as desired by the Tribes.

### **Data Justice**



#### **Data Justice Update**

- The recent request to include Tribal Affiliation within ODE's data collection system passed the Data Governance Committee, unanimously.
- Student Tribal Affiliation data collection inclusion proposed to begin within the 2024-25 school year.
   Please keep in mind the data will take several years to reflect an increasingly accurate reflection of AI/AN Tribally Affiliated student counts.
- Next steps include moving to ODE Exec for potential approval. Following potential passage, forthcoming guidance to professional districts will be initiated, in association with Tribal consultation and communication throughout.
- Chalkboard 2.0 (current study name tbd) with ECOnorthwest is moving into contract. Tribal participation outreach will ensue upon April's return.

#### **ESSER III Updates**

- Additional supplemental funds from ESSER III CTE CCL in collaboration with OTLA CTE Tribal Liaison, Susan Samek.
   Tribes are eligible for \$70k, with the application deadline set for 3/30/24. Funds may be utilized for career development and/or connected learning (summer school).
- Supplemental million-dollar Title VI ESSER III OIE investment in cooperation with OIE's Stacy Parrish.

#### SpEd

- Special Education (SpEd): Participating as an ODE guest during SACSE (State Advisory Council for Special Education)
  meetings.
- Work Product: In progress: Culturally specific and responsive 504/IEP toolkit and mini-guides aimed at supporting AI/AN parents & guardians with EdNW, led by Dr. Mandy Smoker Broaddus. *Desire to present to this body before finalization of the mentioned resources*.

#### **SEL-Health**

- Social and Emotional Learning (SEL) & Health: Engaged in work group activities within ODE Health Education
   Consortium and ODE-OHA Behavioral Health. Recent review of state-mandated ODE-OHA opioid & fentanyl lesson plans.
- - Scheduled site visit in April at the Harmony Academy with the ODE Recovery Team.



#### **Key Priorities March - Summer**

- Supporting current and incoming awardees in their ESSER III Native Investment grants – funds provided to further supplement an awardees' Title VI Indian Education programs or to help them establish strong programs (approximately \$1M in additional funding for Title VI)
- Providing targeted support to our incoming LEAs and LEA-C in the completion of their first ever EASIE Part II applications.
- ➤ Ensuring compliance to Sec. 6119 SEA (OIE) is creating the Smartsheet application submission section. Goal is to have 100% of EASIE Part 2 Final applications on file with OIE by 11:59PM May 12.

# Tribal Consultation Between LEAs, LEA-Cs, and Tribes




#### **Key Priorities March - May**

 Partnering with ODE's Federal Systems Team and the Education, Innovation, and Improvement department to complete first revision of new toolkit - Version 2.1 due April 1 to align with the six month revision window goal
