So my understanding is that the analysis will be done at the level of the pixel (30mx30m), looking at a moving window which will focus the definition and yet provide buffers on structures and other human development. From there, properties will be allocated with WUI based on the pixel-based mapping.

The 1/40 standard might appear in the Fed Register, but that does not make it a "national standard". As I understand it, the definition in the Fed Register had no regulatory impact. It was not used to establish regulations, like SB 762 requires. If we want to stick to "national standards" we need to focus on apples to apples standards, where the WUI definition is being used to create regulatory impacts.

I'm good Sam, thanks for the clarification Chris. I still wonder about the mechanics of the difference between California's influence zone, and our 2.4km screen? I also want to add that the "National Standards" seem very clear to me that they are a framework from which states and other entities can work from. The process for establishing them is far below the bar for regulatory standards.
