#### **Review Background**

- In December 2005 the Oregon Transportation Commission created the Rail Advisory Committee (RAC) and authorized up to 20 positions representing the rail industry, both freight and passenger and other appropriate stakeholders.
- House Bill 2985, passed by the 2021 Legislative Assembly, directs ODOT to diversify its advisory
  committees to reflect Oregon's population's racial, ethnic and ability composition as determined by
  the most recent American Community Survey from the United States Census Bureau.
- March of 2022 the RAC began discussing refreshing membership to meet HB 2985 requirements
- At the special RAC meeting on May 18, 2022, twelve permanent seats were approved by the RAC:
  - Class Is (BNSF and UP) (2), [2 Filled]
  - G&W (1) [1 Filled]
  - Shortlines (3) (Aim for geographic diversity. Chair to ask for volunteers with a preference for geographic diversity and for small SL representation) [2 Filled, 1 Vacant]
  - Passenger railroads (Amtrak) (1) [1 Filled]
  - Rail passenger and transit user representation (1), [1 Vacant]
  - Ports and industries with strong rail connections or use
    - o Oregon Public Ports Association to appoint one permanent seat. (1) [1 Vacant]
    - An industry user of rail freight would be one permanent seat. (1) [1 Vacant]
  - Rail labor union (1) [2 Filled]
  - Local government (1) [1 Vacant]

  - Staff has met with the ODOT Office of Social Equity and they liked the thought and effort that has been put into the refresh.

#### **General Information**

The Oregon Department of Transportation's (ODOT) vision is to provide Oregonians with a safe, equitable, modern and well-funded transportation system.

The purpose of the Rail Advisory Committee (RAC) is to provide state government sound advice on priorities, issues and investments for advancing freight and passenger rail transportation as components of a multimodal Oregon. The committee's work includes scoring for rail projects, such as, Connect Oregon grants. Applicants must have interest in and some understanding of rail transportation.
