Introduction



Background

The Moving Ahead for Progress in the 21st Century Act (MAP-21) required the Secretary of US Department of Transportation to develop rules to establish a system to monitor and manage public transportation assets to improve safety and increase reliability and performance, and to establish performance measures. The Fixing America's Surface Transportation (FAST) Act reaffirmed this requirement. On July 26, 2016, FTA published the Transit Asset Management (TAM) Final Rule.

The National Transit Asset Management System Final Rule (49 U.S.C. 625) requires that all agencies that receive federal financial assistance under 49 U.S.C. Chapter 53 and own, operate, or manage capital assets used in the provision of public transportation create a TAM plan. FTA has identified two types of TAM plans, Tier I and Tier II which each have different requirements. Tier I Operate rail 101 or more vehicles across all fixed route modes or 101 or more vehicles in one non-fixed route mode. Tier II providers are subrecipients of 5311 funds or American Indian Tribe or less than 101 vehicles across all fixed route modes or less than 100 vehicles in one non-fixed route mode. Agencies are required to fulfill this requirement through an individual or group plan. Group plans are designed to collect TAM information about groups (typically smaller subrecipients of 5311 (Formula Grants for Rural Areas) or 5310 (Enhanced Mobility of Seniors & Individuals with Disabilities) grant programs that do not have a direct financial relationship with FTA.

Group plan sponsors must guarantee the option to participate in a group plan to applicable Tier II transit agencies that do not also receive 5307 (Urbanized Area Formula Program) funds. If a subrecipient does not plan to participate, they must “opt-out” in writing and notify the sponsor as to how they will meet their TAM plan requirements, either by participating in a different group plan or by completing an individual plan. Group plan sponsors may determine a direct recipient of 5307 funds may participate in the sponsored group plan if requested by the subrecipient of those funds.

The purpose of the group plan is to reduce the planning and reporting burden on smaller transit agencies from having to develop individual plans and to report to FTA's National Transit Database (NTD) on their own.

Oregon Department of Transportation – Public Transportation Division (ODOT) developed the first Group TAM plan October 2018, on behalf of 53 Tier II transit Subrecipients, within five regions in Oregon, in accordance with Federal Transit Administration (FTA) requirements. Three additional Tier II transit subrecipients joined the Oregon Group TAM plan since inception. This is the first update to the ODOT TAM plan for 56 Tier II transit Subrecipients in Oregon.

In accordance with the FTA regulation the state sponsored group plan must be updated at least every four years. This TAM plan update will cover 2023 – 2026 fiscal years unless updated mid-cycle.

Transit Asset Management is a business model that uses the condition of assets to guide the optimal prioritization of funding at transit properties and keep transit networks in a State of Good Repair (SGR). This group plan is intended to aid in capital lifecycle management and investment strategies utilizing the following core elements:

- **Inventory of Capital Assets:** A register, repository, or comprehensive list of an agency's assets used in support of public transportation and specific information about those assets. The three categories include: Rolling Stock, Equipment and Facilities.
- **Condition Assessment:** The process of assessing and documenting the condition or residual useful life of an asset for which a transit provider has direct capital responsibility.
- **Decision Support Tool:** An analytic process or methodology to help prioritize projects to improve and maintain the state of good repair of capital assets within a public transportation system-based condition assessment.
- **Investment Prioritization:** The investment prioritization is linked to information gained from the asset inventory, condition assessment, and decision support tools to invest in support of target goals and to consider safety and accessibility for all. Prioritization also takes into account the estimated funding levels from all available sources. It is based on the decision support tool and projected funding estimated to be reasonably available over the four-year period.

The FTA TAM regulation requires the setting of annual SGR performance targets for each asset class or category. As the Group Plan sponsor, ODOT is principally responsible for reporting performance data and setting performance targets applicable to all participants utilizing condition and useful life data to calculate the current SRG. The data and targets for the next year are reported to National Transit Database (NTD).

Transit Asset Management Vision

The purpose of developing the group sponsored TAM plan is to aid ODOT in achieving and maintaining a state of good repair (SGR) of all public assets in the State of Oregon. SGR is defined by FTA as “the condition in which a capital asset is able to operate at a full level of performance.” The FTA final rule on transit asset management further defines SGR in §625.41:

“A Capital asset is in a state of good repair if it meets the following objective standards:

- The capital asset is able to perform its designed function
- The use of the asset in its current condition does not pose an identified unacceptable safety risk
- The life-cycle investment needs of the asset have been met or recovered, including all scheduled maintenance, rehabilitation, and replacements.”

TAM and SGR Policy

Transit Asset Management is the strategic and systematic practice of procuring, operating, inspecting, maintaining, rehabilitating, and replacing transit capital assets to manage their performance, risk, and costs over their life cycles for the purpose of providing safe, cost-effective, and reliable public transportation. TAM uses transit asset condition to guide how to manage capital assets and prioritize funding to improve or maintain a state of good repair.

Tier II providers may develop their own plans or participate in a group plan such as ODOT’s TAM Plan. Regardless of whether an agency develops its own TAM Plan or chooses to participate in a group plan, each must designate an Accountable Executive to ensure that the necessary resources are available. An Accountable Executive is a single, identifiable individual within a transit agency who has direct control over the resources needed to implement an agency’s safety plan and transit asset management practices, and who is responsible for the implementation of both of those requirements.

Participants choosing to opt-out of the ODOT TAM Plan must notify ODOT and provide ODOT with a copy of their TAM plan.

Group TAM Plan Sponsor

The Final Rule indicates that state departments of transportation may sponsor Group TAM Plans for their Tier II subrecipients and allows other Tier II providers who are not subrecipients to join in the Plan on a voluntary basis. The Oregon Department of Transportation (ODOT), who administers the FTA grant funding for subrecipients of Section 5310 and 5311 programs, is sponsoring this TAM Plan on behalf of transit providers within the State of Oregon to support subrecipients’ compliance with the FTA Final TAM Rule. The transit providers within this Group TAM Plan are subrecipients of either FTA Section 5310 or 5311 funds for which ODOT is the designated recipient. Subrecipients of Section 5310 included in this plan are open-door providers which provide service to the public. ODOT, as the primary grant recipient for FTA funding provided to 5310 and 5311 transit systems within Oregon, has undertaken development of this Group TAM Plan based on 49 CFR 625.27.

Group TAM Plan Participants

Useful Life



Useful Life Benchmarks

Useful life benchmarks and condition assessments are the key performance criteria utilized in the analysis of capital assets. The FTA defines a useful life benchmark (ULB) as: “the expected lifecycle of a capital asset for a particular transit provider’s operating environment or the acceptable period of use in service for that operating environment.” ODOT’s current useful life criteria for vehicles, equipment and facilities are defined below. Useful life benchmarks are being assessed due to supply chain delays and the nationwide backlog in procuring vehicle chassis. New methods or definitions may need to be implemented to improve the overall SGR.

Vehicles

ODOT uses the ULB benchmarks from the FTA Circular 5010.1e for each capital asset based on age and mileage. Condition is reported by each subrecipient quarterly. Combined age, mileage and condition are the criteria for performance measurement. Age and mileage benchmarks are outlined below based on the category (size) of the vehicle.

- Category A: large, Heavy-Duty Transit Bus. Approximately 35-40 feet, manufactured as Fixed Route Transit Equipment, using diesel (or alternative fuel) engines, and are considered to have a minimum useful life of twelve (12) years, or 500,000 miles.
- Category B: Medium-Size, Heavy-Duty Transit Bus. Approximately 30 feet or more in length, manufactured as Fixed Route Transit Equipment, using diesel (or alternative fuel) engines, and are considered to have a minimum useful life of ten (10) years, or 350,000 miles.
- Category C: Medium-Size, Medium-Duty Transit Bus & Truck Chassis Cutaway. May be purpose built which are assembled using add-on bodies installed by a manufacturer other than the original equipment chassis supplier. These vehicles are usually over 30 feet in length, use gas diesel or alternative fuels. These units shall be classified as having a minimum useful life of seven (7) years, or 200,000 miles.
- Category D: Medium-Size, Light-Duty Bus & Van Chassis Cutaway Bus. Assembled using add-on bodies installed by manufacturers other than the original equipment chassis supplier and usually under 28 feet in length. These units shall be classified as having a minimum useful life five (5) years, or 150,000 miles.
- Category E-1: Small, Light-Duty Bus. Vehicles with modified original equipment by manufacturers of the body and chassis which may include the installation and use of ramps for accessibility. Vehicles are subject to design and specifications approval by ODOT. They must comply with all state and federal requirements. They shall be classified as having a minimum useful life of four (4) years, or 100,000 miles.

- Category E-3: Modified Minivan, Sedan, or SUV. These vehicles are usually less than 20 feet in length and may include the installation and use of ramps for accessibility. They shall be classified as having a minimum useful life of four (4) years, or 100,000 miles.

Equipment

The ULB for equipment non-revenue shop or administrative vehicles is four (4) years, or 100,000 miles. Other equipment with an acquisition value of \$50,000 or more have the following age requirements:

- Computer equipment, software, and other office equipment – five (5) years
- Communications equipment – five (5) years
- Surveillance equipment – five (5) years
- Shop equipment – fifteen (15) years
- Fare boxes – ten (10) years

Facilities

The ULB for all facilities is 40 years for the building which includes administrative, maintenance or a combined unit.

Subrecipients are required to report data for facilities for which they have capital responsibility. Capital responsibility is defined as the following:

You have direct capital responsibility	You do NOT have direct capital responsibility
You own the asset	You do not own the asset AND you are not responsible for replacing, overhauling, refurbishing, or conducting major repairs on that asset, or the cost of those activities are not itemized as a capital line item in your budget.
You jointly own the asset with another entity	
You are responsible for replacing, overhauling, refurbishing, or conducting major repairs on that asset, or the costs of those activities are itemized as a capital line item in your budget.	

Asset Inventory and Condition Assessment



Asset Inventory Data Collection

The required asset inventory is a listing of providers' capital assets which meet the criteria specified in TAM rules. Assets include vehicles, facilities, and equipment that support the delivery of public transportation services. All assets must be scored and reported on in the TAM plan regardless of whether or not they were purchased with FTA or other funds. TAM managed assets include:

- Revenue vehicles and Backup revenue vehicles
- Non-revenue vehicle Equipment
- Facilities with a purchase price value of \$50,000 or greater
- Equipment with an acquisition value of \$50,000 or greater



ODOT requires grant subrecipients and group plan members to submit revenue vehicle mileage and condition data for TAM purposes quarterly. ODOT uses a web portal database designed specifically for grant and asset management, Oregon Public Transportation Information System (OPTIS). The OPTIS portal allows grant recipients to update on a quarterly basis, information on each asset managed by ODOT through State, Federal, and STIF funding. Once data is collected, ODOT computes the performance measures for each of the three Tier II categories: Rolling Stock, Facilities and Equipment using an Excel spreadsheet program with formulas relative to the States criteria for State of Good Repair.

Overview of Asset Inventory and Condition

The ODOT Group TAM plan update data is an indicator of the current SGR in Oregon and will be reviewed to revise replacement strategies. The capital assets in Oregon that support public transportation include a total of 1152 assets. 1035 revenue vehicles, 51 pieces of equipment (including non-revenue support vehicles), and 66 facilities.

Vehicle Data

The current (2021) vehicle asset inventory contains 1035 assets. Through the analysis process the condition assessment tools identified 478 vehicles across all categories in a non-SGR. This equates to 46% of the fleet past useful life criteria. The data analysis is provided below.

The Identified numbers of revenue vehicles past useful life provides a tool for planning and prioritization of grant funds. Of the 1035 revenue vehicles in the Oregon fleet 478 are in a state of non-SGR which calculates to 46%.

Table 2 provides replacement cost estimates from the Oregon State Price Agreement published and updated August 2022. Replacement cost estimates for vehicle types E6-E7 and Articulated Buses are not currently on the Oregon State Price Agreement for ADA vehicles. These figures can be used to provide insight to future subrecipient grant funding needs. The table outlines the estimated replacement cost per category based on the lowest priced vehicle listed on the current Oregon State Price Agreement January 2022. *Current supply chain shortages have increased price estimates and the Oregon State Price Agreement is under review.*

Facility Data

Facility performance scoring is based on age and condition. The condition assessments are completed by the subrecipients using a modified FTA Transit Economic Recovery Model (TERM) scale and a data collection form developed by ODOT. The form includes 10 areas of concentration with sub-sections for each area. The rating system uses a 1-5 rating scale as required by FTA. The facility condition assessments will be conducted once every three years due to the extensive evaluation required. FTA's Transit Economic Requirements Model (TERM) is shown below in Table 3:

A TERM rate of two or more is considered to be in good condition and not in need of immediate replacement. Assets with a TERM rating of less than two will be listed for prioritization replacement if funding is available.

The 2021 facility data analysis collected 66 condition assessments covering 10 inspection areas and sub-components. One General Purpose Maintenance Facility/Depot capital assets rated below two on the condition assessment rating scale which calculates to less than 1%.

Equipment Data

The 2021 equipment data analysis included 44 non-revenue support vehicles and seven other equipment assets that met or exceed the \$50,000 original value threshold. Of the 44 non-revenue support vehicles 25 have exceeded the useful life benchmark analysis threshold. Other equipment assets totaled seven and one is rated as non-SGR.

DECISION SUPPORT



Decision Support Tools

ODOT staff utilize a variety of management practices, policies, and technology to manage, maintain, and plan throughout the lifecycles of our transit assets. The decision support tools ODOT uses for asset management and investment planning include both computer software and written policy. The framework of the decision support tools that are utilized are listed below:

Decision support tools are an analytical process or methodology to understand underlying asset, condition data, and make investment prioritization decisions. These tools have been developed to inform and guide investment prioritization and future funding decisions, as well as adjusting future targets.

Decision priority will be given to replace or repair any vehicle or facility as needed to meet the Americans with Disabilities Act (ADA) and FTA's accessibility guidance.

INVESTMENT PRIORITIZATION



Investment Prioritization

This component of the Group Plan will consider the larger financial constraints, shift towards zero emission vehicles, and supply chain delays. Local, state, and federal funds may limit the action that can be taken toward achieving the desired goals after the four decision support tools have been used. This prioritizing, by design, will be an iterative process taking into consideration the overall fleet of vehicles in the ODOT program and how best to meet or exceed the statewide targets set in the Group Plan.

Approximately 46% the total assets in the ODOT Group Plan inventory have exceeded their ULBs based on 2021 OPTIS data. Investment decisions will be made with the goal to improve the ODOT Group Plan and improve the overall State of Good Repair. ODOT intends to begin a strategizing process to help mitigate supply chain delays and price increase issues. Due to timelines and costs, investment decisions will need to be planned further in advance in order to improve the Oregon Group TAM plan State of Good Repair percentages and maintain a safe reliable transportation fleet.

There are 159 Category D Cutaway vehicles listed in the 2021 OPTIS data analysis that are beyond their ULB. This category represents the fleet with the highest percentage and number of vehicles. They are the mainstay for Public Transportation Providers and provide the outgoing face of transportation. There has been a slight shift in replacement vehicle decisions due to driver shortages and changes in population dynamics statewide. The priority is to replace cutaway vehicles on the inventory list with an overall SGR score below two.

The van categories E1 to E5 have the second highest number and percentage of vehicles beyond their ULB with a total of 153. The second priority is to evaluate fleet needs in this category and monitor manufacture growth in the electric vehicle options with the goal of having no vehicles with an overall score below two.

Should enough funding be available, the third priority will be to reduce the number of vehicles in all other service categories that have a score below two. ODOT will closely monitor incentives and grant opportunities to leverage growth and transition across all categories towards zero-emission transportation vehicle options.

DEFINITIONS

Accountable Executive means a single, identifiable person who has ultimate responsibility for carrying out the safety management system of a public transportation agency; responsibility for carrying out transit asset management practices; and control or direction over the human and capital resources needed to develop and maintain both the agency's public transportation agency safety plan, in accordance with 49 U.S.C. 5329(d), and the agency's transit asset management plan in accordance with 49 U.S.C. 5326.

Asset category means a grouping of asset classes, including a grouping of equipment, a grouping of rolling stock, a grouping of infrastructure, and a grouping of facilities.

Asset class means a subgroup of capital assets within an asset category. For example, buses, trolleys, and cutaway vans are all asset classes within the rolling stock asset category.

Asset inventory means a register of capital assets, and information about those assets. *Capital asset* means a unit of rolling stock, a facility, a unit of equipment, or an element of infrastructure used for providing public transportation.

Decision support tool means an analytic process or methodology: (1) To help prioritize projects to improve and maintain the state of good repair of capital assets within a public transportation system, based on available condition data and objective criteria; or (2) To assess financial needs for asset investments over time.

Direct recipient means an entity that receives Federal financial assistance directly from the Federal Transit Administration.

Equipment means an article of nonexpendable, tangible property having a useful life of at least one year.

Facility means a building or structure that is used in providing public transportation.

FTA – Federal Transit Administration

Full level of performance means the objective standard established by FTA for determining whether a capital asset is in a state of good repair.

Group TAM plan means a single TAM plan that is developed by a sponsor on behalf of at least one tier II provider.

Horizon period means the fixed period of time within which a transit provider will evaluate the performance of its TAM plan.

Implementation strategy means a transit provider's approach to carrying out TAM practices, including establishing a schedule, accountabilities, tasks, dependencies, and roles and responsibilities.

Infrastructure means the underlying framework or structures that support a public transportation system.

Investment prioritization means a transit provider's ranking of capital projects or programs to achieve or maintain a state of good repair. An investment prioritization is based on financial resources from all sources that a transit provider reasonably anticipates will be available over the TAM plan horizon period.

Key asset management activities mean a list of activities that a transit provider determines are critical to achieving its TAM goals.

Life-cycle cost means the cost of managing an asset over its whole life.

ODOT— Oregon Department of Transportation

OPTIS- Transit Division's web-based software that the Public Transit Section uses to manage grants and assets.

Participant means a tier II provider that participates in a group TAM plan.

Performance Measure means an expression based on a quantifiable indicator of performance or condition that is used to establish targets and to assess progress toward meeting the established targets (e.g., a measure for on-time performance is the percent of trains that arrive on time, and a corresponding quantifiable indicator of performance or condition is an arithmetic difference between scheduled and actual arrival time for each train).

Performance target means a quantifiable level of performance or condition, expressed as a value for the measure, to be achieved within a time period required by the Federal Transit Administration (FTA).

Public transportation system means the entirety of a transit provider's operations, including the services provided through contractors.

Recipient means an entity that receives Federal financial assistance under 49 U.S.C. Chapter 53, either directly from FTA or as a subrecipient.

Rolling stock means a revenue vehicle used in providing public transportation, including vehicles used for carrying passengers on fare-free services.

Service vehicle means a unit of equipment that is used primarily either to support maintenance and repair work for a public transportation system or for delivery of materials, equipment, or tools.

Sponsor means a State, a designated recipient, or a direct recipient that develops a group TAM for at least one tier II provider.

State of good repair (SGR) means the condition in which a capital asset is able to operate at a full level of performance.

Subrecipient means an entity that receives Federal transit grant funds indirectly through a State or a direct recipient.

TERM scale means the five (5) category rating system used in the Federal Transit Administration's Transit Economic Requirements Model (TERM) to describe the condition of an asset: 5.0—Excellent, 4.0—Good; 3.0—Adequate, 2.0—Marginal, and 1.0—Poor.

Tier I provider means a recipient that owns, operates, or manages either (1) one hundred and one (101) or more vehicles in revenue service during peak regular service across all fixed route modes or in any one non-fixed route mode, or (2) rail transit.

Tier II provider means a recipient that owns, operates, or manages (1) one hundred (100) or fewer vehicles in revenue service during peak regular service across all non-rail fixed route modes or in any one non-fixed route mode, (2) a subrecipient under the 5311 Rural Area Formula Program, or (3) any American Indian tribe.

Transit asset management (TAM) means the strategic and systematic practice of procuring, operating, inspecting, maintaining, rehabilitating, and replacing transit capital assets to manage their performance, risks, and costs over their life cycles, for the purpose of providing safe, cost-effective, and reliable public transportation.

Transit asset management (TAM) plan means a plan that includes an inventory of capital assets, a condition assessment of inventoried assets, a decision support tool, and a prioritization of investments.

Transit asset management (TAM) policy means a transit provider's documented commitment to achieving and maintaining a state of good repair for all of its capital assets. The TAM policy defines the transit provider's TAM objectives and defines and assigns roles and responsibilities for meeting those objectives.

Transit asset management (TAM) strategy means the approach a transit provider takes to carry out its policy for TAM, including its objectives and performance targets.

Transit asset management system means a strategic and systematic process of operating, maintaining, and improving public transportation capital assets effectively, throughout the life cycles of those assets.

Transit provider (provider) means a recipient or subrecipient of Federal financial assistance under 49 U.S.C. chapter 53 that owns, operates, or manages capital assets used in providing public transportation.

Useful life means either the expected life cycle of a capital asset or the acceptable period of use in service determined by FTA.

Useful life benchmark (ULB) means the expected life cycle or the acceptable period of use in service for a capital asset, as determined by a transit provider/State, or the default benchmark provided by FTA.

Useful mileage benchmark (UMB) means the expected mileage cycle or the acceptable mileage during the life of a capital asset – vehicle, as determined by a transit provider/State.
