

# Child Passenger Safety Technician Recertification Seat Sign-Offs

Recertification requires that Child Passenger Safety (CPS) Technicians and Instructors demonstrate technical and communication skills in the presence of a CPS Instructor or Technician Proxy during the following seat checks:

- Rear-facing-only car seat
- Rear-facing convertible car seat
- Forward-facing car seat with harness
- Belt-positioning booster
- Installation using LATCH

Seat sign-offs may be done at any time during the recertification cycle. The National Child Passenger Safety Board strongly encourages that seat sign-offs be conducted at a checkup event with the caregiver present.

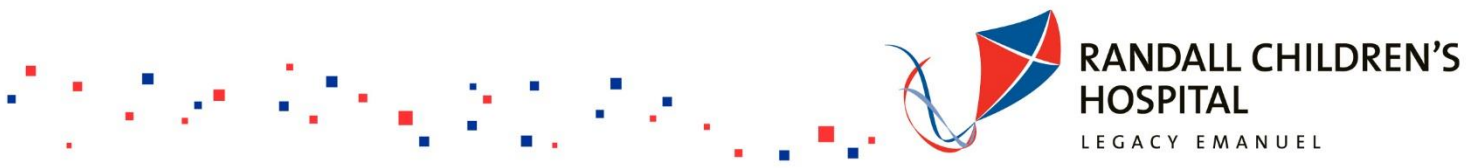
