
The mission of the Oregon Board of Chiropractic Examiners is to protect the public by regulating the practice of chiropractic.

Estimated direct patient care FTE by county





Oregon's DC supply












Number of years licensed in Oregon

On average, DCs spend 72.3% of their time in direct patient care.












Estimated population-to-provider ratio*






Chiropractic assistants (CA)

Workforce supply




Number of years certified in Oregon§




How CAs spend their time

On average, CAs spend 66.6% of their time in direct patient care.




Practice plans in the next two years


