### **Updating Oregon's Strategic Plan for Health IT**

### **New Community Information Exchange Workgroup**

HITOC has approved 15 members for a new <u>Community Information Exchange (CIE) Workgroup</u> to recommend strategies to accelerate, support, and improve CIE across the state. Members represent a broad array of roles and backgrounds within Oregon's diverse landscape of health care, social service partners, and communities that are impacted by development in this area. Please see the HITOC Materials for the <u>membership HITOC</u> approved at their December meeting.

The CIE Workgroup will be meeting monthly throughout 2022. Meetings will be open to the public and available virtually. See the goals and full scope in the <u>CIE Workgroup Charter</u>. Workgroup recommendations will inform HITOC's Health IT Strategic Plan for Oregon and OHA efforts.

#### 2021 Oregon Health IT Survey: Deadline Extension

OHA has launched the 2021 Oregon Health IT Survey in collaboration with CCOs/DCOs to collect health IT information from all contracted organizations, whether or not they use an electronic health record (EHR).

Information collected from the survey will inform:

- CCO efforts to support health IT adoption and use across their provider networks.
- OHA's decisions related to health IT policy, strategy, and funding.

Physical, oral, and behavioral health organizations should have received an email from OHA/SurveyMonkey with a link to the survey. Thank you to the many organizations that already submitted a survey! For those who have not yet had a chance, **please submit your response by December 31**st. The survey includes questions about the following topics:

- Your organization's EHR,
- The health IT tools your organization uses,
- The benefits and barriers to exchanging electronic health information, and
- Patient engagement in health IT.

Your organization's participation in the survey is very important. Whether or not your organization uses health IT is important for CCOs and OHA to know, including the barriers your organization faces with health IT implementation and use. ### **January Education Session: Federal Interoperability Final Rules**

 The Centers for Medicare and Medicaid Services (CMS) Interoperability and Patient Access Final Rule focuses on patient access to electronic health information (EHI) and interoperability among providers, payers and patients. The Office of the National Coordinator for Health Information Technology (ONC) 21st Century
Cures Act (Cures Act) Final Rule focuses on health IT certification, which applies to health IT
developers; and policy guidance on what does not constitute information blocking, which
applies to healthcare providers, health IT developers, and health information
exchanges/networks.

# **Highlights from the December HITOC meeting**

At the December HITOC meeting members approved the membership slate for the CIE Workgroup (see above), heard updates on the strategic plan work, and decided to charter an HIE workgroup. # **Health Information Exchange Onboarding Program Concludes**

Oregon's HIE Onboarding Program launched in January 2019 and concluded September 30, 2021 with the sunsetting of federal funding. The Program leveraged significant federal funding to increase Medicaid providers' capability to exchange health information by supporting the initial costs of connecting (onboarding) priority Medicaid providers to community-based HIEs. Priority Medicaid providers included behavioral health, oral health, and critical physical health. Reliance eHealth Collaborative was selected as the HIE vendor through an RFP process.

By the end of the Program, over \$2.4 million had been spent successfully onboarding 72 unique entities, including 11 behavioral health practices, 4 oral health clinics, 50 critical physical health entities, and 7 major trading partners (hospital/health system/major referral centers) across five regions and seven CCOs. # **Federal Policy**

#### **ONC Announces Continued Collaboration with the Gravity Project**

The Office of the National Coordinator for Health IT (ONC) has renewed its collaboration with the <u>Gravity Project</u> under the FHIR Accelerator Program to support pilot testing of the newly published <u>Social Determinants of Health Clinical Care Implementation Guide</u>. Four new social determinants of health data elements were included in the <u>United States Core Data for Interoperability</u> Version 2. This collaboration offers the opportunity to work with various stakeholders to provide testing of the newly added data elements in real world settings.

# **State Policy**

**OHA Releases Final Policy Concepts and Draft Application for Medicaid Waiver** 

The OHA Medicaid 1115 Demonstration Waiver renewal team announced the publication of the <u>final</u> <u>policy concept papers</u> (including summaries of policy concepts). These papers outline changes OHA proposes to make to the Oregon Health Plan (OHP) as part of its effort to advance health equity. These concepts are the basis of OHA's upcoming application to CMS, whose approval is needed to implement policies reflected in these concept papers. If approved, Oregon would make changes to OHP during the 2022 – 2027 demonstration period.

OHA has developed a <u>draft waiver application</u> to CMS based on these policy concept papers and related feedback. You can provide feedback on the draft waiver application in the following ways 12/7/21-1/7/22:
