
Needs Assessment Findings – TA Format

 - Individualized TA


Needs Assessment Findings – Guidance Documents

- Of the past guidance documents, CCOs found the FAQ document most valuable, followed by the CCO LC Playbook
- In the short answer portion of the survey, CCOs identified that examples and templates for various metric requirements, especially from their CCO colleagues, would be valuable


Priority of TA for each must-pass element – Screening Practices

Needs Assessment Findings – Top Priority Future TA Topics

- Reimbursement strategies and value-based payment arrangements to support screening and referral by clinical and CBO partners
- Increasing CBO resource and capacity through financial, infrastructure, and staffing support
- Strategies for aligning screening and referral protocols across internal CCO, clinical, and CBO partners
- Examples of CCO success in setting up a consistent and effective data sharing approach
- Alignment of SDOH Screening & Referral Measure work and other SDOH Metrics & Policies, including HRS, SHARE, 1115 Waiver, and national HEDIS measures
