CSBG Program Update – April 2024

<p>CSBG Funding Update</p>	<ul style="list-style-type: none"> • The CSBG 23 FY23 and CSBG 23 Discretionary funds need to be expended on or before March 31, 2024. The final FSR for the CSBG 23 FY23 and the CSBG 23 Discretionary funds need to be completed before June 30, 2024. • The consolidated Appropriations Act bill for the CSBG FY24 fund has passed by Congress on 3/23/24, the funding remains level and the 200% may be applied to the CSBG 24 funds. Once OHCS receives the award letter the allocations will be processed as soon as possible. A notice through the gatekeeper will be sent out to notify the network when funds are available.
