Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

**SCENIC WATERWAYS NOTIFICATION**

On August 22, 2023, Notification of Intent 2A-293-23 was approved to allow the additions of an attached garage and second-story living space to an existing single-family dwelling at 5506 NW 83<sup>rd</sup> Avenue in Redmond, within the Scenic River Area of the Middle Deschutes State Scenic Waterway. This NOI was approved because the proposed work is outside of the 100' setback, below the height limit, and finished in materials and colors that blend in with the natural surroundings. The addition will be partially screened from view from the river by topography and vegetation, and landowners will add additional vegetation as a condition of this project's approval. The proposal complies with all relevant Middle Deschutes Scenic River Area rules.

On September 25, 2023, Notification of Intent 2B-1111-23 was approved to allow the construction of a new single family dwelling with an attached car and RV garage, as well as the construction of necessary fencing to delineate property boundaries at 60897 River Rim Drive in Bend, within the Scenic River Area of the Upper Deschutes State Scenic Waterway. This NOI was approved because the proposed work is outside of the 100' setback, below the height limit, finished in materials and colors that blend in with surrounding environment, and maintains existing vegetation screening on-site. This project complies with all relevant Upper Deschutes River Community Area rules.

On October 9, 2023, Notification of Intent 14-30-23 was approved to allow a 65-acre fire salvage in the McKenzie River Scenic Waterway. The harvest is located in T16S, R6E, Sec. 10, Lot 302. The salvage is from the 2020 Holiday Farm Labor Day fire. The NOI was approved to facilitate reforestation, re-vegetation and restoration of the property to occur in a timely manner. After fire restoration efforts in the scenic waterway are important to increase vegetation as soon as possible.

## **OCEAN SHORES ALTERATION DECISIONS**

On October 2, 2023, permit 3039 was issued in Lincoln County for forty-five feet of riprap shoreline protective structure on the ocean shore adjacent to 6455 NW Finisterre Avenue in San Marine, that was installed under a temporary emergency permit.

On October 20, 2023, permit 3030 was issued in Tillamook County for an existing unpermitted wood staircase (approximately 10 feet in height by 18 feet in length by 5 feet in width) west of 3764 Pacific Avenue in Cannon Beach, Oregon.
