Fund Strategy

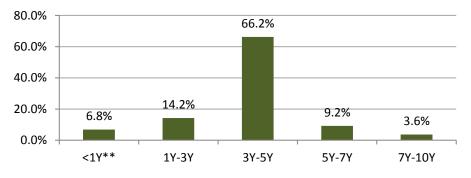

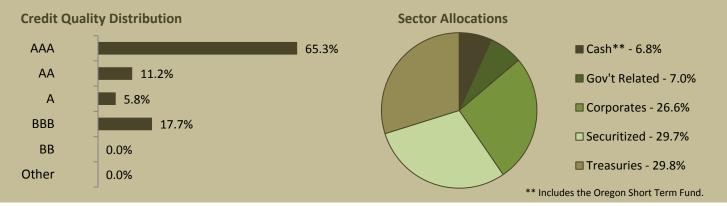
