**PUBLIC TESTIMONY:** The Board of Forestry places great value on information received from the public. The Board will only hold public testimony at the meeting for decision items. The Board accepts written comments on all agenda items except consent agenda and Work Session items [see explanation below]. Those wishing to testify or present information to the Board are encouraged to:

- Provide written summaries of lengthy, detailed information.
- Remember that the value of your comments is in the substance, not length.
- For coordinated comments to the Board, endorse rather than repeat the testimony of others.
- To ensure the Board will have an opportunity to review and consider your testimony before the meeting, please send comments no later than 72 hours prior to the meeting date. If submitted after this window of time the testimony will be entered into the public record but may not be viewed by the Board until after the meeting.
- For in-person meetings, sign in at the information table in the meeting room when you arrive. For virtual meetings, follow the sign up instructions provided in the meeting agenda.

Written comments for public testimony provide a valuable reference and may be submitted before, during, or up to two weeks after the meeting for consideration by the Board. Please submit a copy to [BoardofForestry@oregon.gov](mailto:BoardofForestry@oregon.gov), and written comments received will be distributed to the Board. Oral or written comments may be summarized, audio-recorded, and filed as record. The Board cannot accept comments on consent agenda items or a topic for which a public hearing has been held and the comment period has closed.

Work Sessions provide the Board opportunity to receive information and/or make decisions after considering previous public comment and staff recommendations. No new public comment will be taken. **SUMMARY**

The purpose of this agenda item is to consider the petition for rehearing and/or reconsideration of the final orders issued on November 4, 2020, by the Board of Forestry for the order of the state forester (repair orders) involving several forest practices violations by Siskiyou Cascade Resources LLC (Agency case numbers for one order relate to 19-SW002 and 19-SW003 with a second-order relating to 19-SW007).

**CONTEXT**

The Oregon Forest Practices Act (ORS 527.610 through ORS 527.770) allows for appeals from orders of the State Forester and allows the Board to establish rules to carry out the appeal process.

In OAR 629-001-0050, the Board established a rule that before a party can appeal a Board’s Final Order, the party must first file a petition for reconsideration or rehearing by the Board. Once the Board has ruled on the petition for reconsideration or rehearing, ORS 527.700(2) provides for appeals from the Final Order as allowed by ORS 183.482. The Respondent has taken the next step in the process for appealing the Final Orders issued by the Board on November 4, 2020, involving case numbers 19-SW002 and 19-SW003 for one request and a second-order relating to 19-SW007, both requesting that the Board allow rehearing and/or reconsideration of the Final Orders for each.

**BACKGROUND**

**ODF Case No. 19-SW002 & 19-SW003**

Siskiyou Cascade Resources LLC. (Respondent) appealed the repair orders on September 6, 2019. Siskiyou Cascade Resources LLC (SCR) through legal counsel waived the timeline requirements for this hearing. A contested case hearing was conducted by an administrative law judge (ALJ Triana) on July 9 and 10, 2020. SCR presented no exhibits and 1 witness. The Department presented 68 exhibits and 5 witnesses. An Assistant Attorney General for the Department of Justice (DOJ), represented ODF because of the complexity of the case and possible legal arguments. ALJ Triana issued the proposed final order on July 29, 2020.

ALJ Triana's proposed final order found in favor of ODF's positions and made the following Conclusion of Law:

1. Respondent failed to design and construct a stream crossing over Murphy Creek that allowed migration of fish upstream and downstream during conditions when fish movement in the stream normally occurs, in violation of OAR 629-625-0320(2)(b).
2. Respondent failed to design and construct a stream crossing over Spencer Creek that allowed migration of fish upstream and downstream during conditions when fish movement in the stream normally occurs, in violation of OAR 629-625-0320(2)(b).
3. The Department may require Respondent to cease further violations of OAR 629-625-0320(2)(b).
4. The Department may order Respondent to repair the damage or correct unsatisfactory condition(s) caused by the violation(s) of OAR 629-625-0320(2)(b).

The BOF issued a Final Order on November 4, 2020, that adopted the ALJ's proposed order in favor of ODF, with the only change being to the timeline of required repairs. The Respondent filed the current petition for rehearing and/or reconsideration of the case on December 29, 2020, by US Mail. The petition states:

"Siskiyou Cascade Resources requests rehearing because it is no longer in privity with the owner of the land the subject of the citation and has no authority to enter the subject property and engage in the remediation ordered. At the time of citation and hearing, the subject property was owned by an affiliate of Siskiyou Cascade Resources but the property has subsequently been sold to a private party not enjoined in this matter."

Department staff has consulted with DOJ and recommends that the Board find that Respondent's arguments fail to form a basis for changing the findings of fact or conclusions of law. Staff believes that the Forest Practices Act allows for operators to be held responsible for their violations and that operators must work with landowners to coordinate making repairs on land that the operator does not own. Additional summary background information can be found in the November 4, 2020 Board of Forestry meeting "Proposed final order review – Siskiyou Cascade Resources LLC" staff report. **ODF Case No. 19-SW007**

Siskiyou Cascade Resources LLC. (Respondent) appealed the repair orders on August 21, 2019. Siskiyou Cascade Resources LLC (SCR), through legal counsel, waived the timeline requirements for this hearing. A contested case hearing was conducted by an administrative law judge (ALJ Triana) on August 6, 2020. SCR presented no exhibits or witnesses for this case hearing. The Department presented 47 exhibits and two witnesses. An Assistant Attorney

General for the Department of Justice (DOJ) represented ODF because of the complexity of the case and possible legal arguments. ALJ Triana issued the proposed final order on August 21, 2020.

ALJ Triana's proposed final order found in favor of ODF's positions and made the following Conclusion of Law:

1. Respondent failed to drain skid trails by water barring or other effective means immediately following completing of the operation, resulting in significant down-slope erosion and delivery of excessive sediment to waters of the state, in violation of OAR 629-630-0300(3).
2. The Department may require Respondent to cease further violation of OAR 629-630-0300(3).
3. The Department may order Respondent to repair the damage or correct unsatisfactory condition caused by the violation of OAR 629-630-0300(3).

The BOF issued a Final Order on November 4, 2020, that adopted the ALJ's proposed order in favor of ODF. The Respondent filed the current petition for rehearing and/or reconsideration of the case on December 29, 2020, by US Mail. The petition states:

“Siskiyou Cascade Resources requests rehearing because the record fails to establish statutory or administrative authority for the contention of the Department that it can place future deadlines on further remediation where failure to meet the deadline is subject to citation. Here, Siskiyou Cascade addressed the immediate concerns of the Department in January but the Steward Forester wanted additional remediation completed by mid-June. Siskiyou Cascade completed the additional remediation but didn't finish to the satisfaction of the Department until August. This citation issued for failure to meet the deadline given by the Steward Forester and there is no authority for this penalty where, as here, there is no immediate risk of detriment to the resource if the deadline is not met.”

Staff has consulted with DOJ and recommends that the Board find that Respondent's arguments fail to form a basis for changing the findings of fact or conclusions of law. Additional summary background information can be found in the November 4, 2020 Board of Forestry meeting “Proposed final order review – Siskiyou Cascade Resources LLC” staff report. ## **ALTERNATIVES CONSIDERED**

Upon review of the petitions, the Board can:

A) Accept or deny the petition:

- 1) Accept the petition at public meeting within 60 days; proceed to (B)
- 2) Deny the petition at public meeting within 60 days
- 3) Take no action and the petition shall be deemed denied by a matter of law on the 60th day following the date the petition was filed

B) If the petition is accepted, then the Board can:

- 1) Take steps to evaluate the arguments or clarify the record:
  - a) Board evaluation of written or oral arguments
  - b) Refer the matter back to the Office of Administrative Hearings (OAH) for further hearing on specific factual issues
- 2) Ultimately make a decision to Modify or Affirm or Withdraw the Final Order

## **RECOMMENDATION**

### ODF Case No. 19-SW002 & 19-SW003

The Department recommends alternative A(2) as the Respondent's Petition fails to present any new information that justifies changing the findings of fact or conclusions of law.

### ODF Case No. 19-SW007

The Department recommends alternative A(2) as the Respondent's Petition fails to present any new information that justifies changing the findings of fact or conclusions of law.


