## PWR FAQs

### Did you know...

Certified payroll reports must be submitted to the public contracting agency once a month, by the fifth business day of the following month.

### **Q. What if a worker is performing more than one classification of work?**

A. A contractor or subcontractor must carefully track how much time is spent doing each type of work. Contractors and subcontractors must pay employees the applicable prevailing rate for the hours they spend in each work classification. If the contractor's records do not clearly show the time spent in each classification, the contractor must pay the worker at the highest classification rate for all hours worked.
