CCB License Renewal Process Changes with New Endorsement Program

CCB's Licensing Section has been working hard to implement the new endorsement system that became effective July 1, 2008 for new and renewing contractors.

Renewing under the new Endorsement system has presented contractors with new license requirements and a new form to complete for license renewals.

"We have a more comprehensive renewal process than we've had in the past, due to the endorsement system," says Kristie Patton, Licensing & Customer Service Unit Manager. "It is important for contractors to read the new instructions in order to understand how to fill out the new form completely."

The CCB is receiving a number of incomplete renewal forms which must be returned to the licensee to complete. This delays the renewal of the license. The most common error is returning the

form to the CCB without including the new bond. The new endorsement system requires the purchase of a new bond or bonds, which match the new endorsement or endorsements that contractors have chosen for their business. The amounts for all bonds have changed.

Other sections of the renewal form that have been commonly overlooked by renewing licensees are the court judgments and convictions section, and the RMI signature section. If the licensee has no judgments or convictions, "not applicable" (NA) must be selected in order to complete that section.

CCB's Licensing Section is encouraging contractors to call 503-378-4621 if there are any questions about how to complete the new renewal form to avoid any delay in receiving their licenses.

Oregon OSHA – Resource for Construction Site Safety

Construction is one of the most dangerous industries for workers. Site injuries or deaths resulting from falls, collapsing scaffolding, crane failures, falling objects, falling structural details, trench cave-ins, and falling machinery are usually preventable by following safety procedures that avoid

risk. Promotion of safety and health management on construction sites is good for workers, employers, and the construction industry.

Businesses that implement safety plans report seeing lower injury and

illness rates, overall reduction in costs, decreased workers compensation costs, production increases, lower employee turnover, and higher worker morale.

How does a construction business start a safety program? Oregon OSHA provides safety and health program assistance with <u>confidential</u> consultation services. The agency also offers workshops around the state, including some Spanish–language classes, on topics that range from vehicle safety to OSHA recordkeeping and fall protection. Online courses, onsite education, newsletters, and other publications are some of the free offerings.

According to OSHA, R & H Construction, Inc. in Portland started

working with Oregon OSHA more than five years ago when the company joined the Safety and Health Achievement Recognition Program (SHARP). SHARP provides an incentive for Oregon employers to work with their employees to find and correct hazards, develop and implement effective safety and health programs, and continuously improve. The ultimate goal of SHARP is to encourage employers to become selfsufficient in managing workplace safety and health issues. Gary Stonewall, safety coordinator for R & H Construction, Inc. says, "It has been very beneficial in changing our safety program from one that looked good on paper to one that is an important working part of all aspects of our company—from the accounting department to the carpenter on the job site."

CCB's "MY LICENSE"

CCB's "My License" is a web-based computer application that lets contractors conduct certain business actions with the CCB on-line. After signing up for a CCB My License account, contractors can:

- Update their address, phone numbers, and email address in the CCB records
- Obtain help in securing liability insurance (Contractor MAP)
- Check and monitor the status of their license as well as the status of the contractors working with them (E-Watch)

CCB's "E-Watch" is an automated system imbedded in My License that lets you monitor the status of other licensed contractors (such as subcontractors). Any time the CCB license status of a contractor on your E-Watch list changes, you will receive a status report automatically, via email, informing you of the change (including failure to have proof of proper liability insurance or bond). The purpose of the

system is to help general contactors comply with the law, best business practices, and to only work with properly licensed bonded and insured subcontractors.

You can also use CCB's E-Watch to monitor your own license so you will be warned immediately in the event that your license record needs attention.

CCB Steps Up Investigation Efforts Against Unlicensed Contractors

The Construction Contractors Board (CCB) has stepped up efforts to find unlicensed contractors. In February the CCB partnered with Portland FOX affiliate (KPTV) to conduct a sting in the Portland area. Last month, the CCB partnered with the Oregon Home Builders Association and conducted a sting in the Eugene/Springfield area.

Prior to the stings, the CCB obtained leads of unlicensed construction activity from advertisements, public complaints, Craig's list, public bulletin boards, and other unnamed sources.

In each operation, suspected unlicensed contractors were invited to offer bids for improvements and repairs. In Portland, CCB's Investigators and Compliance Officers received nine bids for construction work. All were found in violation of Oregon's construction contracting laws (working without a license). In Eugene, seven of the eight bids were found in violation.

"Illegal activity doesn't just hurt the consumer," says Robert Rambo, CCB Field Investigation Manager. "It hurts

the legitimate contractors that work hard to stay in compliance only to get undercut by those who don't. The CCB is committed to finding and penalizing those working illegally."

The CCB has stepped up its proactive efforts throughout the state to address illegal activity. These efforts include random jobsite checks at any given time, on any day of the week; multiagency enforcement sweeps (saturation of targeted areas to check jobsites for illegal activities); and additional enforcement stings.

"These efforts are designed to address unlicensed activity, as well as other illegal practices that may put Oregon workers at risk, and provide an unfair competitive advantage to outlaw contractors hiring workers under the table," says Craig P. Smith, CCB Administrator. "The CCB shares its findings with other state agencies to help penalize violators to the fullest extend of the law."

Tell CCB if You Owe a Court Judgment

Beginning January 1, 2008, Oregon requires that a contractor must send the Board a copy of certain court judgments. A contractor must send a copy of any judgment ordering the contractor to pay damages relating to construction or proposed construction. This requirement applies if the damages are for:

- Breach of contract
- · Negligent work or
- Improper work

The requirement includes court judgments and court orders upholding arbitration awards.

You must send CCB a copy of the judgment, <u>unless</u> you pay the judgment within 30 days or appeal the judgment. You should make sure that CCB receives the copy of the judgment no more than 45 days after it is recorded. If you fail to send the CCB a copy of the judgment, the CCB may impose a civil penalty. 

CCB Monitors craigslist for Illegal Contractors

Craigslist has grown into a world-wide advertising platform for both legal and, sometimes, illegal services.

The CCB recognizes the frustration of licensed contractors when unlicensed contractors advertise on craigslist. This illegal activity undermines the success of the construction industry, puts consumers at risk, and takes business away from legitimate contractors.

The CCB conducts regular reviews of craigslist to find illegal contractors advertising for work without a license. Electronic mail warnings, written warning notices, or orders imposing a civil penalty are sent to the offending party. They are also informed of the laws that require licensing of anyone who intends to work as a contractor in the State of Oregon. Those who aren't already presented with a fine, are informed of the penalties for continuing to work or advertise without a license. They are also given

information on how to become licensed. The advertisements are then "flagged as prohibited" on craigslist. Along with notifying those who are working illegally, the CCB also contacts legitimate contractors who advertise on craigslist, thanking them for complying with Oregon Construction Laws and supporting the industry. Some of the recent comments from licensed contractors include:

"Thank you...We were also concerned about all of the contractors soliciting business without a license. Especially now that business is sort of flat. Thanks for all your help."

"Thank you. I spend time each time we post to be certain that we are up to par with the requirements necessary to keep us legal and am glad to hear that that time is helping to keep us legal with CCB requirements. This is the first time I have received an email from CCB regarding our posts on craigslist and I am very glad to see that there is time being devoted to seeing that those advertising online are in compliance."

"As a licensed contractor trying to make a living, I very much appreciate your efforts to enforce compliance with the requirements of the State and CCB. Thank you."

"Thanks for your email! Glad to know that I am in compliance!! I am glad you all are checking up on ads on craigslist. Contractors put out a lot of money to be in business and it burns me up to be underbid by someone unlicensed. Once again thank you and have a nice day."

"I am glad to see that you folks are staying on top of checking folks out. I am so excited to work this year on my own. I hear of people working all the time under the radar and it makes no sense to me. It's so much easier in this life to just man or woman up and do things the right way. I guess some people will never learn or get it though."

The CCB will continue to review craigslist postings in our efforts to enforce Oregon's construction licensing laws.

EPA Issues New Rule to Help Stop Childhood Lead Poisoning: Important Requirements for Contractors

The U.S. Environmental Protection Agency (EPA) recently issued a new rule, called the "Lead: Renovation, Repair, and Painting Rule." The new rule aims to protect children from lead-based paint hazards created by renovation and remodeling projects in places they frequent, including homes, day cares and schools.

This is the most important effort in the last decade to help fight lead poisoning in young children. Exposure to lead can cause serious behavior and learning problems in children. The most common way children get lead poisoning is through exposure to lead-contaminated dust

The new rule requires that contractors and maintenance professionals be certified, that their employees be trained, and that they follow protective lead-safe work practice standards. The rule focuses on housing, childcare facilities, or schools built before 1978, where children under the age of six are present, or where an expectant mother resides.

The rule will require contractors working in the types of facilities listed above to follow simple, effective work practices. These include posting warning signs, restricting occupants from work areas, and containing work areas to prevent dust and debris from spreading. These practices will help

protect children and pregnant women from being exposed to dangerous levels of lead. The rule also prohibits open flame burning or torching of lead-based paint.

Larger Bonds for Commercial Contractors – Level One

After July 1, 2008, every new and renewing contractor license must choose an endorsement. If a contractor performs work in connection with large commercial structures (or develops land for that use), the contractor must have a commercial contractor endorsement.

For a commercial general contractor level one (CGC1) or a commercial specialty contractor, level one (CSC1), the new law requires a larger bond. A CGC1 must have a \$75,000 surety bond, and a CSC1 must have a \$50,000 surety bond.

NOTE: Contractors endorsed as a commercial general contractor, level two (CGC2), or a commercial specialty level two (CSC2) are required to provide a \$20,000 surety bond.

Some contractors have asked where they can find these bonds.

Any insurance company licensed to sell surety bonds may issue these bonds. So far, Developers Surety & Indemnity Company, Travelers Casualty & Surety Company, and Western Surety Company have sold the largest number of these bonds.

Another company that sells a larger percentage of all contractor bonds sold in Oregon is Contractors Bonding & Insurance Company (CBIC).

The companies usually sell their bonds through agents. If a contractor already has an insurance agent, that person is probably the best source for purchasing the larger bond. Another way to locate an agent is to look up a company's website. There will ordinarily be a link to a list of agents. If not, call the company for a list of agents. (Some agents may sell bonds for multiple companies.)

According to companies surveyed by the CCB, the \$50,000 bond should cost around \$600 per year. The \$75,000 bond costs around \$900 - \$1,000 per year. There may be discounts for buying bonds for a period of more than one year.

The companies we surveyed indicated that they "underwrite" the bond sales. This means that, like making a loan, the companies consider the credit status of the bond purchaser. The company may require the contractor to provide a satisfactory corporate or personal financial statement. To purchase one of these larger bonds, a contractor may need a good credit score.

There will be contractors who do not qualify to purchase the larger bond from certain companies. Those contractors should consult their agents. Those larger bonds, if available, will likely be more expensive.

Important Continuing Education Information for Commercial Contractors

Contractors that currently hold a CCB endorsement as a commercial contractor, will be required to certify that they have completed the required number of continuing education hours at their next renewal. For example, if a contractor became endorsed as a commercial contractor on July 1, 2008, they would complete continuing education and certify that they have done so, at the next license renewal on July 1, 2010.

Continuing education is not required for contractors endorsed as a commercial developer, or are commercially endorsed contractors licensed as electricians, plumbers, boiler/vessel pressure contractors, or elevator contractors

How much continuing education is required for contractors with a commercial endorsement?

The number of continuing education hours for commercially endorsed contractors, is dependent upon type of endorsement and the number of key employees. (A key employee includes an employee or owner who is a corporate officer, manager, superintendent, foreperson, or lead person.)

The chart below is for commercial endorsements only and is based on a two-year license period.

Where can contractors with a commercial endorsement find continuing education?

The law allows continuing education to be provided by colleges (community or four-year), universities, trade schools, trade associations, professional societies, private companies (including manufacturers), public agencies, business associations, and in-house training programs.

What kind of CE qualifies?

Topics for continuing education include manner and means, and business practices.

At this time, the CCB does not have a list of available continuing education classes.

Does this mean I should start taking education now?

If you are currently endorsed as a commercial contractor, then yes, you should begin taking and tracking the continuing education you and your key employees take so you can certify the hours required on your next renewal.

Will I have to start complying with continuing education if I obtain a commercial endorsement?

Yes. Once you become endorsed as a commercial contractor, you should begin taking and tracking continuing education taken. You will be required to certify the continuing education hours at the following renewal.

What about residential contractors?

The continuing education program for contractors with a residential endorsement is in development. Oregon law provided most of the requirements for continuing education for contractors with commercial endorsements. Statute covering residential contractors is broad. The Continuing Education System (CES) committee continues to meet with the goal of developing a common sense program that serves both the business community and consumer interests. These are public meetings and can be found on the CCB website.

Civil Penalties Issued April 1, 2008 – June 30, 2008

The Oregon Construction Contractors Board (CCB) recently announced final orders assessing civil penalties issued to Oregon contractors for violation of the Construction Contractors Law (ORS 701). Oregon law requires all construction contractors to be licensed with the CCB before they advertise, bid on, or perform construction, remodeling, or repair work.

The CCB issued 311 penalties between April 1, 2008 and June 30, 2008. The most common type of violation was operating as a contractor while not licensed. Contractors receiving penalties include: (See Violations Key on pages 14 and 15.)

Home Inspector Standards of Behavior for Advertising Clarified

The Board has amended Home Inspector Standards of Behavior (OAR 812-008-0201), effective July 1, 2008. The amended rule provides a clearer explanation of the accepted methods of advertising and defines restrictions on receiving financial compensation.

The amended rule makes it clear that:

- Home Inspectors are not restricted from advertising their services, or advertising to recruit employees and personnel.
- Home Inspectors cannot directly or indirectly, compensate realty agents or other parties having a financial interest in closing or settlement of real estate transactions in return for referrals of home inspections or for being included on any list of preferred or recommended home inspectors.
- Home Inspectors can utilize the offering of discounts, credits, and add-on services to customers in their advertising.

The amended rule also clarifies the restrictions on business activities that may involve receiving any form of compensation.

- Home Inspectors may not accept compensation, directly or indirectly, for recommending contractors, services, or products to customers or other parties having an interest in inspected properties.
- Home Inspectors cannot accept financial or other consideration, such as material or equipment from suppliers, for recommending or promoting the use of a specific product during an inspection.

Locksmith Industry Seeks Stricter Licensing **Standards**

The Pacific Locksmith Association (PLA) has asked State Representative Linda Flores (Clackamas) to draft legislation that will upgrade regulation of the locksmith industry. State Representative John Huffman (The Dalles) will co-sponsor the bill.

The association is seeking stricter licensing and operating laws.

In 2007, the Better Business Bureau reported that locksmith complaint statistics rose nationwide by 75% from 2005 to 2006. Consumers reported being overcharged, charged for unnecessary services, and intimidated.

Mercury Thermostats Annual Notification (ORS 701.550)

It is against the law for any person to install a thermostat containing mercury in commercial or residential buildings.

This rule does not prohibit the installation on thermostats containing mercury on industrial equipment used for safety controls. (ORS 455.355) (OAR 918-440-0510)

The 2001 Oregon Legislature passed The Oregon Mercury Reduction Act which phased out the use of mercury in certain consumer products for which there are readily available alternatives.

What's the buzz?

CCB's Field Investigation Section: Protecting Consumers and Licensed Contractors

Knowing that unlicensed and illegal construction activity is bad for consumers and legitimate contractors, the CCB established the Field Investigation Section in 2007, to provide statewide coverage and immediate response to complaints of unlawful activity in the construction industry. The staff of 13 includes 11 investigators, each assigned to their own district in the state, where they are positioned to respond to complaints of illegal construction activity and conduct random checks of local construction sites. Sweeps and stings are executed to find those involved in unlawful construction activity. The Field Investigation Section also

participates in joint investigations with other state, county, and city agencies, some of which lead to the filing of injunctions or criminal charges.

Since January 1, 2008, the CCB has conducted 4,220 job site checks, two sweeps, and two sting operations, leading to 490 referrals to the CCB's Enforcement Section for administrative action. There have been a total of 151 referrals to other agencies, including the Department of Justice, Department of Revenue, Oregon Employment Division, Workers Compensation Division, Building Codes Division, and the Landscape Contractors Board.
