CCB Reminds Contractors of the Lead-Based Paint Safety Requirements in Oregon

The Construction Contractors Board (CCB) reminds Oregon construction contractors that enforcement of the new lead based paint (LBP) safety regulations continues in Oregon.

The new LBP requirements, commonly called "RRP" (Renovation, Repair and Painting) requirements, are federal EPA requirements that became effective April 22, 2010. States can apply to the EPA to administer the program.

The CCB began enforcing the new LBP requirements when the EPA authorized Oregon to "take over" the program in May 2010.

Contractors that remodel or demolition homes, schools, or facilities where children regularly visit, constructed in and before1978, are required to obtain from the CCB, a certified Lead-Based Paint Renovation (LBPR) Contractors license. To qualify, an owner or employee must complete the RRP training from an approved provider and complete a CCB LBPR application. The license is \$50 a year and can be renewed annually.

The RRP training is an eight hour course that instructs contractors on the required practices to protect the public from lead contaminants. These standards of practice are found in Oregon Administrative Rule (OAR) 333-070-0090.

"CCB recognizes the new requirements have made for tough state laws," says Richard Blank, Enforcement Manager. "At the same time, the agency takes seriously the enforcement of these laws for the protection of the public."

Fines for working without the proper licensing or violating standards of practice are \$1000 (first violation), \$3000 (second violation) and \$5000 (third and subsequent violations).

Opt-out removed from lead-based paint renovation rules

On September 24, 2010, DHS adopted a temporary rule making two significant changes to its Lead-Based Paint (LBP) rule, OAR 333-070-0075.

The first change removed the opt-out provision. A homeowner can no longer "opt out" of the work practice standards requirements.



This change removed the ability of a homeowner to provide the contractor a signed statement that the renovation is (1) for the homeowner's home; (2) no pregnant woman or child under the age of six resides in the home; and (3) the housing is not a child-occupied facility.

NOTE: The EPA (federal) law removed the ability of the homeowner to optout beginning July 1, 2010.

The second change removed the ability of landlords to work on rental

housing without first complying with the LBP renovation laws.

On September 24, 2010, DHS adopted additional temporary rules amending OAR Chapter 333 Division 69 (Lead-Based Paint Activities). These rules only make minor changes.

The temporary rules expire on March 22, 2011. DHS expects to have permanent rules in place by then.

CCB surprises uncertified locksmiths and unlicensed contractors

Eugene- On August 24, 2010, uncertified locksmiths and unlicensed contractors in the Eugene area had a surprise waiting for them.

The Construction Contractors Board (CCB) conducted a sting operation designed to curb uncertified locksmith and unlicensed contractor activity in the area. The CCB issued five proposed orders for unlicensed construction activity and three proposed orders for uncertified locksmith activity. The CCB partnered with the Lane County Home Builders Association to locate a sting house.

"Illegal activity doesn't just hurt the consumer," says Robert Rambo, Manager of CCB's Field Investigations. "It hurts the legitimate contractors that work hard to stay in compliance only to get undercut by those who don't. The CCB is committed to finding and penalizing those working illegally."

Though licensing of construction contractors have been part of Oregon law since the 1970's, laws requiring locksmith certification and licensing became effective July 1, 2010. Locksmiths in Oregon are required to be certified and the business licensed by the CCB unless exempted by law.

Prior to the sting, the CCB obtained leads from advertisements, Craig's list, public bulletin boards, and other unnamed sources.

The CCB has stepped up enforcement efforts throughout the state with more stings planned as well as job-site checks happening at any given time on any day of the week.




CCB Administrator Named 1st Vice President of National Association of State Contractor Licensing Agencies

Public Works Bond Required For All Public Works Projects

Oregon law requires independent contractors working on qualifying public works projects to file a \$30,000 bond with the Construction Contractors Board (CCB). The bond is required if any project costs more than \$100,000. The bond will be used only for successful prevailing wage claims. Such claims are filed with the Bureau of Labor and Industries (BOLI).

Public works projects are constructed for public agencies, like the state, a city or a school district. Public works projects include:

- Roads, highways, buildings, structures and improvements built to serve the public interest.
- Public-private projects using at least \$750,000 in public funds.
- Public-private projects in which at least 25 percent of the square footage of the completed project is occupied or used by a public agency.



The bonding requirement applies to all contractors – including those not licensed by CCB. For example, flaggers, landscapers and transportation companies must have a bond. The surety bond that contractors hold for their CCB license does not satisfy this requirement.

Contractors may obtain a bond from any insurance company authorized to write surety insurance in Oregon. Contractors should contact their insurance agent to find a company.

Contractors must obtain the public works bond <u>before</u> starting work on a contract or subcontract. The bond must stay in effect for the duration of the project. Contractors only need one bond for all of their projects.

Contractors licensed by CCB should mail or deliver the <u>original</u> bond to the CCB.

Contractors not licensed by CCB should complete the form at: https://ccbed.ccb.state.or.us/WebPDF/CCB/Publications/ PWB Bond application.pdf

They must send the form, with the <u>original</u> bond, to the CCB.

There are some contractors, and circumstances, that are not subject to the bonding requirement. A certified disadvantaged, minority, women or emerging small business may elect to be exempt from filing the public works bond for up to four years* from their initial certification that is obtained from the Office of Minority, Women and Emerging Small Business (OMWESB).

Contractors should submit to CCB a completed exemption form, https://ccbed.ccb.state.or.us/WebPDF/CCB/Publications/ Pwb Application Exemption.pdf. Check with the Office of Minority, Women and Emerging Small Business for information about certification. Additionally, contractors are not subject to the bonding requirement if a public agency makes a declaration of emergency.

*The initial OMWESB certification is for 3 years. In order to get the 4th year of the exemption, they need to submit their OMWESB recertification.

Civil Penalties Issued July 01, 2010 - September 30, 2010

The Oregon Construction Contractors Board (CCB) recently announced final orders assessing civil penalties issued to Oregon contractors for violation of the Construction Contractors Law (ORS 701). Oregon law requires all construction contractors to be licensed with the CCB before they advertise, bid on, or perform construction, remodeling, or repair work.

The CCB issued 264 penalties between July 01, 2010 and September 30, 2010. Contractors receiving penalties include (see Violations Key).
