SUMMARY

Provides that insurer and self-insured employer may keep records of workers' compensation claims at location outside this state if insurer or self-insured employer makes records available to Department of Consumer and Business Services at location inside this state.

Provides that person that awards contract to another person is not responsible for providing workers' compensation insurance coverage for individuals who perform labor under contract if other person is licensed as construction contractor or landscape contracting business.

- Be It Enacted by the People of the State of Oregon:
 - **SECTION 1.** ORS 656.021 is amended to read:
- 7 656.021. [Notwithstanding ORS 656.029 (1), a person who is licensed pur-
- 8 suant to an application under ORS 701.046 and is acting under a contract to
- 9 perform work described by ORS chapter 701 shall be considered the subject
- 10 employer for all individuals employed by that person.] For purposes of de-
- 11 termining whether a person that awards a contract to another person
- 12 is responsible for providing workers' compensation coverage to indi-
- 13 viduals who perform labor under the contract, the provisions of ORS
- 14 656.029 do not apply if, before labor under the contract commences, the
- 15 **other person:**
 - (1) Has a construction contractor license issued by the Construction

- 1 Contractors Board and performing the work of the contract requires 2 a construction contractor license under ORS chapter 701; or
- (2) Has a landscape contracting business license issued by the State Landscape Contractors Board and performing the work of the contract requires a landscape contracting business license under ORS 671.510 to 671.760.
- 7 **SECTION 2.** ORS 656.455 is amended to read:

- 656.455. (1)(a) Except as provided in paragraph (c) of this subsection, 8 every self-insured employer shall maintain a place of business in this state 9 where the employer shall [keep] process claims and make available com-10 plete records of all claims for compensation made to the employer under this 11 12 chapter. [or] In lieu of maintaining a place of business in this state for the purpose of complying with this section, a self-insured employer may, 13 under the conditions prescribed by ORS 731.475 (3), [keep] make such records 14 available at places of business in this state [at places] operated by service 15 companies. 16
 - (b) The [records shall be retained in, and may be removed from, this state or disposed of,] self-insured employer may dispose of the records described in paragraph (a) of this subsection only in accordance with [the] rules [of] the Director of the Department of Consumer and Business Services adopted [pursuant to] under ORS 731.475. Such records [shall] must be available to the director for examination and audit at all reasonable times upon notice by the director to the employer.
 - (c) A self-insured employer may process claims remotely from a place of business in this state in accordance with rules adopted under ORS 731.475.
- 27 (2) With the permission of the director, a self-insured employer may [keep all claims records and] process claims and make available claims records from a location outside of [the] this state. The director shall by rule prescribe the conditions and procedure for obtaining permission of the director.

 31 The director may revoke permission for failure of the employer to comply

- 1 with the rules. If the permission of an employer is revoked by the director,
- 2 the employer [shall be allowed] has 60 days after the order of revocation
- 3 becomes final to comply with subsection (1) of this section. The **self-insured**
- 4 **employer shall pay any** expenses [of] the director **incurs** to examine and
- 5 audit the records [of a self-insured employer] outside of this state [shall be
- 6 paid by the employer].

- SECTION 3. ORS 731.475 is amended to read:
- 12 731.475. (1)(a) Every insurer authorized to issue workers' compensation
- 13 coverage to subject employers as required by ORS chapter 656 shall maintain
- 14 a place of business in this state where the insurer shall:
- 15 [(a)] (A) Process[, and keep] claims and make available complete re-
- 16 cords of[,] claims for compensation made to the insurer under ORS chapter
- 17 656.
- [(b)] (B) Make available upon request complete records, including all re-
- 19 cords submitted electronically, of all workers' compensation insurance poli-
- 20 cies issued as required by ORS chapter 656.
- 21 [(c)] (C) [Keep] Make available records identifying the specific persons
- 22 covered by an employer electing coverage pursuant to ORS 656.039.
- 23 (b) Notwithstanding the requirement in paragraph (a) of this sub-
- 24 section that an insurer process claims at a place of business in this
- 25 state, the Director of the Department of Consumer and Business Ser-
- 26 vices by rule may allow the insurer to process claims remotely from
- 27 a place of business in this state.
- 28 (2) [Claims records must be retained in, and may be removed from, this
- 29 state or disposed of,] An insurer may dispose of the records described in
- 30 subsection (1) of this section only in accordance with the rules of the di-
- 31 rector [of the Department of Consumer and Business Services]. The records

- 1 must be available to the Department of Consumer and Business Services for
- 2 examination and audit at all reasonable times upon notice by the department
- 3 to the insurer.
- 4 (3) In lieu of [establishing] maintaining a place of business in this state
- 5 for the purpose [required by] of complying with this section, an insurer may
- 6 [keep] make such records available at places of business in this state [at
- 7 places of business] operated by service companies, if:
- 8 (a) Each service company is incorporated in or authorized to do business
- 9 in this state;
- (b) [The] **An** agreement [entered into] between the insurer and the service
- 11 company grants each service company a power of attorney to act for the
- 12 insurer in workers' compensation coverage and claims proceedings under

- (c) The agreement [entered into] between the insurer and each service
- 15 company is approved by the director.
- 16 (4) Notwithstanding subsection (3) of this section, an insurer may not:

- 18 insureds unless the insured has service contracts with other insurers; or

- 23 SECTION 5. The amendments to ORS 656.021, 656.455 and 731.475 by
