For the most recent month with finalized numbers – August 2017 – the Total Health Systems - Medicaid caseload was 0.2 percent higher than forecast (2,198 individuals). The most recent preliminary estimate – November 2017 – is 1.2 percent higher than forecast (12,285 individuals). For November 2017, the top three caseloads with the largest numerical variances are: ACA - 6,022; Children's Medicaid - 4,195; and CHIP - 2,214. The top three caseloads with the largest percentage variances are: BCCTP - 14.3%; Pregnant Women - 6.4%; and CAWEM Prenatal - 3.0%.

Non Medicaid Covered Children and Teens

Non Medicaid Covered Children and Teens (NMC) is a new state funded program beginning January 1, 2018. It provides medical assistance similar to the Oregon Health Plan to all children in Oregon under the age of 19 who are under 300% of the Federal Poverty Level (FPL) and are otherwise eligible for Medicaid except for U.S. Residency/Citizenship status.
