Instructions for Oregon Marijuana Tax Monthly Payment Voucher

General information

Licensed marijuana retailers must collect the marijuana tax at point of sale and remit it to the Department of Revenue. The tax is imposed on recreational marijuana products. All sellers of recreational marijuana products are required to remit the tax by the last day of the month following the month in which it was collected. As of January 1, 2017, only retailers licensed by the Oregon Liquor Control Commission can sell recreational marijuana.

Account number

You may include any of these in this field:

- Oregon business identification number (BIN).
- Marijuana tax account number. All marijuana tax accounts received a new marijuana account number in November 2016 in conjunction with our Core Systems Replacement. Contact Department of Revenue if you need your marijuana account number.
- OLCC license number, beginning with 050-.

If you sell recreational marijuana products in more than one location, you must have a separate number, make separate payments, and file separate returns for each location.

State tax rate

ORS 475B.705 designates eight categories of marijuana products. All products are taxed at a rate of 17 percent.

Calculating the Tax

After November 16, 2016, you can go to Revenue Online (ROL) to help calculate your payment at www.oregon.gov/dor. If you're a licensed retailer, ROL can also produce a completed payment voucher.

Physical site address

List the physical (street) address of the location in which the business sold recreational marijuana products.

Tax due calculation

Line 1. Enter the total retail sales for recreational marijuana products sold during the reported month. Total retail sales are all amounts paid by a person for the purchase of recreational marijuana products in Oregon, other than taxes.

Line 3. Enter the total state tax you collected by multiplying lines 1 and 2.

Line 5. Calculate your administrative fee by multiplying the total tax collected by 0.02.

Line 6. Subtract line 5 from line 3.

Local tax due calculation

For businesses paying local tax to the Department of Revenue:

Line 7. Enter the tax rate for your locality, using Table A.

Line 8. Enter the total local tax you collected by multiplying lines 1 and 8.

Line 9. Enter the administrative fee for your locality, using Table A. It is usually zero.

Line 10. Calculate your local administrative fee, if applicable, by multiplying lines 8 and 9.

Line 11. Subtract line 10 from line 8.

Total tax due

Line 12. Add lines 6 and 11. If you don't pay local tax to the Department of Revenue, lines 6 and 12 should be equivalent.

Submit voucher with payment

Make check payable to **Oregon Department of Revenue**. Mail the completed voucher with payment on or before the payment due date to:

Include your account number on any checks or money orders you submit.

Or bring the completed voucher with payment to your scheduled payment appointment. An appointment is required to pay your marijuana tax in cash. To make an appointment, call (503) 945-8050 at least 48 hours in advance.

Due date

Your marijuana tax **payment is due monthly** on or before the last day of the month for recreational marijuana sales in the preceding month. If the due date falls on a weekend or holiday, payment is due no later than the next business day.
