**Excluded:** Performers, Front of House Staff, Ticket Sellers, Ticket Takers, Ushers, Office Staff, Booking Employees, Event Coordinators, Guards, Students whose employment is incidental to or an integral part of their academic curriculum, Faculty Members, volunteers, employees who are members of other certified or recognized bargaining units of Employer, exempt, supervisory, managerial and confidential employees, and all other employees excluded by law.
