- 11 Certificate of Removal Registration:** (A Certificate of Removal Registration allows funeral directors employed by a licensed funeral establishment (FE) licensed in a contiguous state to remove human remains from Oregon before submitting a death certificate. In order to qualify, an FE must be located in a neighboring state with removal laws substantially similar to Oregon's. Each branch of a registrant's FE is a separate establishment and must be registered as a fixed place of business. ORS 432.317(9); ORS 692.160(a); ORS 692.270 (Once approved, registrations remain valid until surrender, change of ownership or Board action.)

Apprentice funeral service practitioner and embalmer certificates will not be granted to any person for a period longer than 48 aggregate months. When an apprentice has completed his or her apprenticeship, he or she will no longer be licensed as an apprentice, but must qualify either as a licensed embalmer or licensed funeral service practitioner. Oregon Administrative Rules (OAR) 830-011-0020(8)

Extensions of the 48 aggregate month period for completion of an embalmer apprenticeship may be granted by the Board due to extenuating circumstances beyond the control of the apprentice. OAR 830-011-0040(2)
