On December 5, 2008, the Oregon Mortuary and Cemetery Board (Board) properly served a notice on Robert Hall (Hall) that it intended to revoke his Preneed Salesperson Registration (OMCB License No. PN-7384) for violation of OAR 830-030-0100(9), OAR 830-050-0050(5) and (9), ORS 692.180(1)(b) and (g), and ORS 97.931(3). Hall requested a hearing on December 23, 2008. On January 6, 2009, the Board properly served an amended notice on Hall that it intended to revoke his Preneed Salesperson Registration for violation of OAR 830-030-0090(2)(c)(D), OAR 830-030-0090(2)(d)(B), OAR 830-030-0100(9), OAR 830-050-0050(2), (5) and (9), ORS 692.180(1)(a), (b) and (g) and ORS 97.931(3). The amended Notice designated the Board's file on this matter as the record for purposes of default. Hall withdrew his request for a hearing on January 15, 2009.

FINDINGS OF FACT

Whereas, the Department of Consumer and Business Services (DCBS), Insurance Division, entered Stipulated and Final Order, Case Number INS 08-08-003 against Respondent for forging the signature of a consumer on a funeral services contract in violation of ORS 744.074(1)(k); and

Whereas, Respondent's Insurance license #613172 was revoked by DCBS,

Insurance Division in Case Number INS 08-08-003 for violation of ORS 744.074(1)(k);
and

Whereas, the facts and circumstances involved in the foregoing enforcement actions involve fraudulent and dishonest conduct that bears a demonstrable relationship to funeral service practice which is cause for revocation of Respondent's Preneed Salesperson Registration pursuant under OAR 830-050-0050(9), OAR 830-030-0100(9), ORS 692.180(1)(b) and (g), and ORS 97.931(3); and

Whereas, as set forth in the amended Notice, the foregoing disciplinary actions against Respondent are cause for revocation of Respondent's Preneed Salesperson Registration under OAR 830-050-0050(5), ORS 692.180(1)(g) and ORS 97.931(3); and

Whereas, as set forth in the Notice, Respondent engaged in dishonest conduct when making untruthful statements to an Insurance Division investigator which is cause for revocation of Respondent's Preneed Salesperson Registration under ORS 692.180(1)(b) and (g), OAR 830-050-0050(9) and ORS 97.931(3); and

Whereas, as set forth in the Notice, Respondent engaged in misrepresentation and made untruthful statements on his 2008/2010 Preneed Salesperson Registration Renewal Application when he failed to disclose his recent criminal history which is cause for revocation of Respondent's Preneed Salesperson Registration under ORS 692.180(1)(a) and (g), OAR 830-030-0090(2)(c)(D), OAR 830-030-0090(2)(d)(B), and OAR 830-050-0050(2).

NOW THEREFORE, after considering the Board's file relating to this matter, the Board enters the following Final Order by Default:

1. Respondent's Preneed Salesperson Registration certificate is hereby revoked.
2. This Final Order shall become effective when signed by the Executive

Director of the Board.
