Certificate of Removal Registration: A Certificate of Removal Registration allows funeral service practitioners employed by a licensed funeral establishment (FE) licensed in a contiguous state to remove human remains from Oregon before submitting a death certificate. In order to qualify, an FE must be located in a neighboring state with removal laws substantially similar to Oregon's. Each branch of a registrant's FE is a separate establishment and must be registered as a fixed place of business. ORS 432.317(9); ORS 692.160(a); ORS 692.270 (Once approved, registrations remain valid until surrender, change of ownership or Board action.)
