IMPORTANT INFORMATION

A) TO RECEIVE YOUR CONSULTANT LICENSE:

1. Complete the form on the other side of this page.
2. Return this completed application and applicable fee (see Section #5) to the Board of Tax Practitioners within **60 days of the date of exam**. If you do not send the required materials by this deadline, you must retake the exam to become licensed.
3. Licenses will not be processed until all required information and fees are received and processed by the Board office.
4. Licenses must be conspicuously displayed in the holder's place of tax employment.
5. No continuing education credit is required for the *first renewal* of a tax consultant's license. A minimum of **30 hours** continuing education must be completed during each license period thereafter.

B) OWNER/OPERATOR OF A BUSINESS:

1. If your tax business will operate under a name other than your personal name, or if the firm is a corporation, the business name and/or the corporation must be registered with the Oregon Secretary of State Corporation Division. For more information, contact the Corporation Division web site at: sos.oregon.gov or (503) 986-2200.
2. Complete the enclosed application for a Tax Preparation Business Registration and return the completed form to the Board office with applicable fee. (See Section #5 for restrictions on eligibility for a combination LTC license/ Tax Business Registration.)
A tax preparation business may *not* offer services to the public until it is registered with the Board.
3. If your tax business has more than one owner, only one of the owners needs to complete a tax business registration.
4. Each tax preparation business must appoint and report to the Board the name of a "Designated Consultant" who will have overall responsibility for the tax activities of the firm. See OAR 800-025-0040 and OAR 800-025-0050.
5. Each office of a tax preparation business must be staffed by a "Resident Consultant", see OAR 800-025-0060.
6. Tax consultant licenses and tax business registrations expire May 31st.
