### **CONTEXT**

The purpose of this staff report is to update the Board of Forestry on the work of their Subcommittee on Alternative Forest Management Plans. While the Subcommittee did not meet in December, the Division did continue working on this effort. This agenda item will provide a brief update on the development of a “land allocation” approach to managing State Forests.

### **BACKGROUND**

The Board directed the Department to consider revisions to the State Forests Management Plan to meet two goals: financial viability and an increase in conservation outcomes. The Board of Forestry met on November 5<sup>th</sup>, 2014 and reached a unanimous decision accepting the Subcommittees recommendation to pursue a “land allocation” forest management approach. The Board also provided direction to staff for modeling a range of strategies to help write and inform the future forest management plan. Following the Board of Forestry recommendation on November 5<sup>th</sup>, 2014 staff began writing and modeling the future management plan. Staff will provide an update on this work at the January 7<sup>th</sup>, Board of Forestry meeting.

### **NEXT STEPS**

Careful drafting of the plan revision is important to ensure the next plan meets the twin goals and is implementable on the six northwest State Forest Districts. This involves sophisticated modeling and analyses, review by the field organization, and overall assessment on the likelihood of achieving established goals.

#### Continued Outreach and Collaboration

Staff will continue to work in collaboration with Trust Land County Commissioners, specifically the Forest Trust Lands Advisory Committee. The Department will continue to lead an ongoing public process and seek stakeholder input.

#### Upcoming Products

Key products that will be developed between now and July 2015 include:

1. Principles for Conservation and Wood Production: This will include definitions of conservation and financial viability and a series of metrics to measure success in achieving conservation and financial viability goals.
2. Forest Management: This new plan will use a land allocation approach, defining how areas will be managed for conservation and production.
3. Modeled Outputs: Our ability to meet our goals will be estimated with a spatially explicit model and include future projections.
4. Science Review: The draft plan and modeled outputs will be reviewed by an independent science team.
5. Board of Forestry Approval for Rulemaking: The intent is to seek Board Approval to begin rulemaking with a Draft Plan by the July Board of Forestry meeting. This will initiate the formal rulemaking process including a series of public hearings.
