

STATE OF OREGON – DEPARTMENT OF FORESTRY FIRE RESTRICTIONS – REGULATED CLOSURE PROCLAMATION

NUMBER 01

EFFECTIVE 12:01 a.m., PDT, 06/15/2026

By virtue of the authority vested in me under the provisions of ORS 477.535 to 477.550, I hereby proclaim a Regulated Closure to be in effect in the following subject area: All lands protected by the West Oregon Forest Protection District.

Under this Regulated Closure, except as to the owner's legal right of entry upon their land, entry to all forestland is unlawful unless entrants comply with the following restrictions:

RECREATIONAL FIRES (CAMPFIRES, CHARCOAL, COOKING, and WARMING FIRES):

Portable appliances, camp stoves, and fire pits using liquefied or bottled fuels are allowed at all levels of fire danger in areas clear of flammable vegetation

- **LOW FIRE DANGER (GREEN)** ALLOWED ALL DAY WITH LANDOWNER PERMISSION
- **MODERATE FIRE DANGER (BLUE)** PROHIBITED EXCEPT AT DESIGNATED LOCATIONS
- **HIGH FIRE DANGER (YELLOW)** PROHIBITED EXCEPT AT DESIGNATED LOCATIONS
- **EXTREME FIRE DANGER (RED)** PROHIBITED AT ALL LOCATIONS

REQUIREMENTS for LOW, MODERATE, and HIGH FIRE DANGER WHEN RECREATION FIRES ARE ALLOWED:

- The surrounding area is free of flammable vegetation AND;
- 1 Shovel available for immediate use AND;
- 1 Gallon of water OR a 2 ½ pound or larger fire extinguisher OR charged hose at activity location

POWER SAW USE OR OTHER SPARK-EMITTING INTERNAL COMBUSTION ENGINES:

- **LOW FIRE DANGER (GREEN)** ALLOWED ALL DAY
- **MODERATE FIRE DANGER (BLUE)** ALLOWED ALL DAY
- **HIGH FIRE DANGER (YELLOW)** ALLOWED BEFORE 1:00 P.M. and AFTER 8:00 P.M.
- **EXTREME FIRE DANGER (RED)** PROHIBITED

REQUIREMENTS for LOW, MODERATE, and HIGH FIRE DANGER USE FOR THIS ACTIVITY:

- 1 Shovel available for immediate use AND;
- 2 ½ pound or larger fire extinguisher OR a charged hose at activity location of use AND;
- 1-Hour Fire Watch is required at the location of activity following completion of the work AND;
- Other Internal Combustion Engines must be used in areas free of flammable vegetation.

CUTTING, GRINDING, WELDING METAL:

- **LOW FIRE DANGER (GREEN)** ALLOWED ALL DAY
- **MODERATE FIRE DANGER (BLUE)** ALLOWED ALL DAY
- **HIGH FIRE DANGER (YELLOW)** ALLOWED BEFORE 1:00 P.M. and AFTER 8:00 P.M.
- **EXTREME FIRE DANGER (RED)** PROHIBITED

REQUIREMENTS for LOW, MODERATE, and HIGH FIRE DANGER USE FOR THIS ACTIVITY:

- The area is free of flammable vegetation AND;
- 2 ½ pound or larger fire extinguisher OR a charged hose at activity location

FIREWORK USE WITHIN THE REGULATED CLOSURE AREA:

- **PROHIBITED** AT ALL LEVELS OF FIRE DANGER

MOWING DRIED, CURED GRASS:

- **LOW FIRE DANGER (GREEN)** ALLOWED ALL DAY
- **MODERATE FIRE DANGER (BLUE)** ALLOWED ALL DAY
- **HIGH FIRE DANGER (YELLOW)** ALLOWED BEFORE 1:00 P.M. and AFTER 8:00 P.M.
- **EXTREME FIRE DANGER (RED)** PROHIBITED

MOTOR VEHICLE and ALL TERRAIN VEHICLE (ATV) / MOTORCYCLE – USE & TRAVEL:

- Vehicles, ATVs, and Motorcycles travelling on State Highways, County Roads, and Driveways are exempt from all requirements and restrictions listed in this section.
- Vehicles, ATVs and Motorcycles are allowed to travel on improved roads all day if compliance is met with the requirements listed below within this section.
- The use of machinery/equipment for the culture and harvest of agricultural crops are exempt from all requirements and restrictions related to use and travel.
- Improved roads are gravel roads that are adequately maintained for safe travel and are free from flammable vegetation on/near the roadway.
- Unimproved roads are primitive roads that lack consistent maintenance, may follow the natural terrain of the land, and have vegetation on/near the roadway. OHV Roads/Trails are considered Unimproved Roads.

THE FOLLOWING RESTRICTIONS APPLY FOR TRAVEL / USE ON UNIMPROVED ROADS:

- **LOW FIRE DANGER (GREEN)** ALLOWED ALL DAY
- **MODERATE FIRE DANGER (BLUE)** ALLOWED ALL DAY
- **HIGH FIRE DANGER (YELLOW)** ALLOWED BEFORE 1:00 P.M. and AFTER 8:00 P.M.
- **EXTREME FIRE DANGER (RED)** PROHIBITED

REQUIREMENTS for travel in a MOTOR VEHICLE on IMPROVED / UNIMPROVED ROADS:

- 1 Shovel AND;
- 2 ½ pound or larger fire extinguisher OR 1 Gallon of water.

REQUIREMENTS for travel on an ATV or MOTORCYCLE on IMPROVED / UNIMPROVED ROADS:

- 2 ½ pound or larger fire extinguisher

THE FOLLOWING ACTIVITIES ARE PROHIBITED IMMEDIATELY DURING FIRE SESAON CLOSURES

- BACKYARD DEBRIS BURNING AND;
- THE USE OF EXPLODING TARGETS AND;
- DISCHARGING TRACER AMMUNITION AND;
- SKY LANTERNS (THE.USE.OF.SKY.LANTERNS.ARE.PROHIBITED.ALL.YEAR) AND.
- SMOKING (EXCEPT.IN.VEHICLES.ON.IMPROVED.ROADS.OR.AREAS.FREE.OF.FLAMMABLE.VEGETATION)

The State Forester or an authorized representative may, in writing, approve a modification or waiver of these requirements. These restrictions shall remain in effect until replaced, suspended, or terminated by an additional proclamation of the State Forester or an authorized representative.
