

# Chapter M

## Fees

### General fee information

The correct fee to collect for any transaction depends on the type of vehicle and the type of transaction being done. The most common transaction types are:

- Title transfer
- Registration (original or renewal)
- Plate replacement
- Plate transfer

### ***Transaction examples:***

If you are submitting an application for a vehicle with an out-of-state title and issuing Salmon plates, collect the following fees for the transaction:

Title fee (new to Oregon vehicle)  
+VIN inspection fee  
+Salmon surcharge for one or two plates  
+Plate fee for one or two plates  
+Registration fee for the vehicle type  
=Total fee

If you are submitting an application for a vehicle with a current Oregon title, renewing the registration, and replacing the plates with tree plates collect the following fees for the transaction:

Title fee (Oregon title transfer)  
+At-renewal replacement plate fee  
+Plate fee for one or two plates  
+Renewal (registration) fee for the vehicle type  
=Total fee

*For more information on the privilege/use tax on new vehicles, see [Chapter R, Dealers](#), or visit <https://www.oregon.gov/dor>*

**Note:** Do not include the privilege/use tax fee on the application.

### Title fee information

The amount of the title fee is based on the vehicle type and weight and whether or not the title being replaced or applied for is a salvage title. It is necessary to know the weight of the vehicle even if the vehicle is not being registered.

1. Title fees for heavy motor vehicles are based on the gross vehicle weight rating (GVWR). A \$90.00 title fee is charged for the following vehicle types (referred to as "Heavy Vehicles"):
  - Trailers with a loaded weight over 8,000 pounds (this does not apply to other vehicle types such as special use trailers and travel trailers).
  - Motor vehicles with a gross vehicle weight rating (GVWR) over 26,000 pounds (this applies to all truck, bus, and motorized heavy fixed load title transactions, but this does not apply to motor homes).
2. Title fees and replacement title fee for all other vehicles not described above is

\$93.00 (referred to as "Regular Vehicles"). Salvage certificate fee and replacement salvage certificate fee for all vehicle types is \$27.00.

### Four-year registration fee information

The following new vehicles are subject to four-year registration, for the first registration period (see [Chapter K](#) for more background information):

- Passenger vehicles (including electric and hybrid)
- Light trailers
- Mopeds (all motive power types, including electric and hybrid)
- Motorcycles (all motive power types, including electric and hybrid)

The registration fee will double in addition to any surcharges or special fees (such as the custom plate fee). The surcharge for Crater Lake, Cultural plates, Pacific Wonderland, Portland Trail Blazers, Wine Country, Share the Road, and Special Registration Plate Program plates is NOT doubled. After the initial four-year registration period, the renewal will revert back to a two-year registration period.

### Exceptions to four-year registration:

- Vehicle types not listed above
- Plate transfers
- Vehicles applying for permanent registration
- Rental or leasing companies that elect to initially register new passenger vehicles for a one or two year period

## County registration fees

**Multnomah County:** The additional Multnomah County registration fee is \$19 per year of registration. Heavy trailers with a permanent registration are assessed a one-time county registration fee of \$10.

Information about Multnomah County registration fees is located at <https://multco.us/bridge-services/about-county-vehicle-fee>.

**Washington County:** The additional Washington County registration fee is \$30 per year of registration. Heavy trailers with a permanent registration are assessed a one-time county registration fee of \$10. Motorcycles and mopeds will pay an additional \$17 per year of registration.

Registration fees are collected based on the registration period of the vehicle, rather than the transaction date.

County registration fees are based on the customer's vehicle address, residence address or business address (in that order) at the time of application for registration. When filling out applications for title and registration, please include the total registration fee amounts, including county registration fees if applicable, in the REG/REN FEE box on the application.

Most vehicle types are subject to the county registration fees. The tables below list which vehicles are subject and which vehicles are exempt from the county registration fees.

The first table below shows the subject vehicles and corresponding amounts. The second table below shows exempt vehicles and registration types.

## **Tree (Graphic), Oregon Trail, “OR 150” Pacific Wonderland, Salmon, Crater Lake, Cultural and Wine Country Plates**

### ***"Graphic" plates terminology***

The tree plate was the original graphic plate. When mentioned in older DMV literature, "graphic" means the tree plate.

### ***Tree plates***

Tree plates are issued:

- For light trailers (only option available)
- For passenger vehicles, as regular issue, and custom
- As background for most non-veteran related group plates
- As background for National Guard plates and Elected Official plates
- As background for Disabled Veteran plates (full size only; not moped or motorcycle)

When tree plates are issued in **conjunction with original registration** (new vehicles or new to Oregon) there is no replacement fee. The fees that should be collected are the plate fee and the registration fee (see fee charts), and custom or group plate fee, if applicable.

When tree plates are issued or replaced in **conjunction with the renewal** of the registration plates, the at-renewal replacement fee of \$5.00 per transaction is charged in addition to the plate fee and registration renewal fee, and custom plate or group plate fee if applicable.

If the customer wishes to apply for replacement tree plates at any time between renewals, they will pay the between-renewal replacement fee of \$10 in addition to the plate fee.

The plate fee is \$12 for vehicles requiring one plate, and \$24.50 for vehicles requiring two plates.

### **Disabled Veteran Plates**

To assist a customer in applying for Disabled Veteran Plates and for more information about qualifying for a Disabled Veteran Plate, see [Chapter K](#).

A permanent registration fee of \$15 plus the plate fee is required at the time of initial application. The registration is valid for as long as the person who qualified for the Disabled Veteran Plates remains an owner.

### **Group plates** (*issued only to passenger vehicles*)

To assist a customer in applying for Group plates, for more information about qualifying for a group plate, and for group plate transfer information, see [Chapter K](#).

Group plates are issued only for passenger vehicles. Veteran related group plates are issued on a white background with a military insignia. Most non-veteran related group plates are issued on the tree plate, except Gold Star Family plates, and Share the Road plates, which have a different design. Many of the veteran group plates have specific eligibility requirements; contact DMV for more information about eligibility. When the plates are issued or renewed, a surcharge is collected (see [surcharge fee chart](#) in this chapter), which goes into an account for the group.

When group plates are issued in conjunction with original registration (new vehicles or new to Oregon) the fees collected are the surcharge, the plate fee and the registration fee.

**GROUP PLATES ISSUED OR REPLACED WITH DIFFERENT TYPE GROUP PLATE:** Collect the replacement fee, group plate surcharge, plate fee, and if at renewal, the registration renewal fee.

**GROUP PLATES REPLACED WITH THE SAME TYPE OF GROUP PLATE:** Collect the replacement fee, group plate surcharge, plate fee, and registration renewal fee at renewal.

No group plate surcharge is charged when replacing a group plate with the same type of group plate between renewals.

For more information on surcharges, see [surcharge fee chart](#) later in this chapter.

### **National Guard plates**

Active Members of the Oregon National Guard are eligible for National Guard plates. National Guard plates are issued on tree plates for passenger vehicles and motor homes. One of the owners on the title must qualify for the plate. If there is a lessor and lessee on the title, the lessee must qualify for the plate. The qualified applicant must submit a completed Oregon Military Department Certificate of Eligibility, AGO Form 4309, issued by

the Oregon Military Department. For more information and for plate transfer information, see [Chapter K](#).

The fee for National Guard plates is the same as for regular tree plates:

### **Government Vehicle plates**

The registration fees for government vehicle plates (E plates) are:

Original plates (one-plated vehicle) .....	\$17.00
Original plates (two-plated vehicle) .....	\$29.50

### **Oregon Trail plates**

On November 4, 1993, DMV began issuing the Oregon Trail license plate. Oregon Trail plates are no longer issued but still may be renewed and transferred. See [Chapter K](#) for information about plate transfer requirements.

### **Pacific Wonderland plates**

“OR 150” Pacific Wonderland plates may be issued to passenger vehicles only and may not be issued with a custom or ham configuration.

Registration fees for “OR 150” Pacific Wonderland plates are the same as for regular registration for passenger vehicles plus a surcharge of \$100 per set of plates whether it is 2-year or 4-year registration. The surcharge is required only when “OR 150” Pacific Wonderland plates are initially issued.

If between renewals and the application is a change from any other plate type to “OR 150” Pacific Wonderland plates, charge the replacement fee of \$34.50 plus the “OR 150” Pacific Wonderland surcharge.

### **Salmon plates**

Salmon plates or custom Salmon plates may be issued for passenger vehicles. Passenger vehicles may also have Ham configuration on Salmon background. The Salmon plate surcharge is distributed to two funds: half to the Watershed Conservation Operating Fund and half to the State Parks and Recreation Department Fund. Salmon plates may be transferred to another vehicle of the same type - see [Chapter K](#) for plate transfer requirements.

*When Salmon plates are initially issued or renewed, a surcharge of \$7.50 per plate per year of the registration period is collected. See [surcharge fee chart](#) in this chapter.*

When Salmon plates are issued in conjunction with original registration (new vehicles or new to Oregon) the fees collected are the surcharge of \$7.50 per plate per year of the registration period, the plate fee and the registration fee.

When Salmon plates are issued to an Oregon-registered vehicle, the fees collected are the replacement fee, the Salmon plate surcharge, plate fee, and, if at renewal, the registration renewal fee.

When Salmon plates are replaced (customer already has Salmon plates), the fees collected are the replacement fee, plate fee, and, if renewing, the registration renewal fee and the surcharge. No surcharge fee is collected if the customer is replacing Salmon plates between renewal.

**Crater Lake plates** (Crater Lake plates are issued only to passenger vehicles)

Crater Lake plates or custom Crater Lake plates may be issued for passenger vehicles. Passenger vehicles may also have Ham configuration on Crater Lake background.

**The surcharge is required only when the plates are initially issued.** The surcharge is not doubled when issuing Crater Lake plates on a vehicle with four-year registration. The surcharge is distributed to the Oregon Community Foundation for use on Crater Lake National Park projects. Crater Lake passenger plates may be transferred to another vehicle of the same type - see [Chapter K](#) for information about plate transfer requirements.

*When Crater Lake plates are initially issued, a surcharge of \$15.00 per plate is collected. See [surcharge fee chart](#) in this chapter.*

When Crater Lake plates are issued in conjunction with original registration (new vehicle or new to Oregon) the fees collected are the surcharge of \$15 per plate, the plate fee and the registration fee.

When Crater Lake plates are issued to an Oregon-registered vehicle (customer does not already have Crater Lake plates), the fees collected are the replacement fee, the Crater Lake plate surcharge, plate fee, and, if renewing, the registration renewal fee.

When Crater Lake plates are replaced (customer already has Crater Lake plates), the fees collected are the replacement fee, plate fee and, if at renewal, the registration renewal fee. No surcharge is collected if the vehicle already has Crater Lake plates.

<p>Vehicles subject to weight-mile tax through the Motor Carrier Transportation Division (MCTD) must be registered with MCTD. This applies primarily to vehicles with a registration weight of 26,001 pounds or more. This also applies to Tow/Recovery vehicles hauling property for-hire, subject to the registration fees under ORS 803.420(14).</p> <p>Vehicles with registration weights of less than 26,001 pounds also may be subject to weight-mile tax if the vehicle's combined weight is 26,001 pounds or more. This would include, for example, a vehicle used exclusively to tow manufactured structures, since the manufactured structure is not included in the registration weight, but is part of the combined weight. If the combined weight of your vehicle is 26,001 pounds or more, you must register it with MCTD.
