I understand it is a crime, under ORS 803.070 and 803.075, to knowingly make any false statement relating to the application or assignment of a title to a vehicle. This offense is a Class A Misdemeanor and is punishable by a jail sentence of up to 1 year, a fine of up to \$6,250, or both.

INSTRUCTIONS FOR FORM

This form must be completed by the person shown as the owner on the out-of-country ownership document, unless that person cannot be reached to complete and sign it. If that person cannot be reached, then Lines 1, 4, and 5 are to be completed by the person applying for Oregon Certificate of Title.

Line 1: Complete all vehicle information.

Line 2: Print the name of the country that issued the ownership document submitted.

Line 3: Print the name of the country that is being certified as having no security interest filed.

Line 4: Print the name of the owner shown on the out-of-country ownership document, if that person is available to sign the form. If that person is not available, print the name of the applicant for Oregon title.

Line 5: Signature of the owner shown on the out-of-country ownership document, if that person is available to sign the form, and the date signed. If that person is not available, signature of the applicant for Oregon title, and the date signed.
