I certify this vehicle is (must check one box):

ASSEMBLED

- Has a body that does not resemble any particular year model or make of vehicle; and
- Is not rebuilt by a manufacturer or built in a factory where the year model and make are assigned at the factory; and
- Is not an antique, special interest, reconstructed, or replica vehicle; and
- Meets the NFPA 1192, NFPA 501C or ANSI A119.2 standard in effect at the time of manufacture, if a recreational vehicle; or
- Meets the ANSI A119.5 standard in effect at the time of manufacture, if a park model recreational vehicle.

RECONSTRUCTED

- Has a body that resembles and primarily is a particular year model or make of vehicle; and
- Is not rebuilt by a manufacturer or built in a factory where the year model and make are assigned at the factory; and
- Is not a replica; or
- Is a motor truck rebuilt using a component kit, if the manufacturer of the kit assigned a VIN and provided a Manufacturer's Certificate of Origin for the kit.

REPLICA

- Has a body built to resemble and be a reproduction of another vehicle of a particular year model and manufacturer. Includes vehicles:
 - Built as replicas from new, reconditioned, or original parts; or
 - Reconstructed from existing vehicles or parts of vehicles, and the vehicle would otherwise meet the definition of a replica.

OTHER INFORMATION

TOTALED VEHICLE:

- Declared a total loss by an insurer obligated to cover the loss, or insurer takes possession of or title to the vehicle.
- Sustained damage not covered by an insurer, estimated repair cost is at least 80% of the retail market value prior to the damage.
- Stolen vehicle, loss not covered by an insurer, not recovered within 30 days of loss.
- Must be titled as assembled, reconstructed or replica even if no repairs completed.

MAJOR PARTS (other than frame or unibody):

- Buses: Body (if not unibody), engine, kit
- Campers: Body
- Heavy Trailers: Axle, body
- Motor Homes: Body (if not unibody), engine, kit
- Motorcycles: Engine, transmission
- Passenger Vehicles: Body (if not unibody), engine, kit
- Trucks: Engine, cab, kit (must have MCO if kit)
