- All trip permit books are sent via UPS to the main business location on record.
- Fully complete trip permit order requests. Incomplete requests will cause a delay in filling your order, and the request may be returned for additional required information.
- Allow 10 days for the issuance and delivery of trip permit books.
- Send the DMV copy (white) within 5 days of the issue date to DMV Record Services, 1905 Lana Ave NE, Salem OR 97314.

Refund Process

- To request a trip permit refund, you must return the "DMV" and "window" copies of the voided trip permit to the Business Licensing Unit, 1905 Lana Ave NE, Salem OR 97314, with a written explanation as to why the permit was voided.
- DMV will return refund requests if this process is not followed. Do not send the blue (dealer) copy or the trip permit book if requesting a refund for less than the entire book.
- Voided trip permits will be refunded for the following reasons:
 - o Incorrect vehicle information.
 - Incorrect owner information including misspelled names, or putting the first name before the last.
