Check the appropriate box below for the requested group plate:

- Purple Heart** – Provide one of the following as proof that you have received the Purple Heart Medal:
- Form DD214 – Certificate of Release or Discharge from Active Duty or DD215 – Correction to Form DD214.
  - U.S. Department of Defense letter listing the Purple Heart Medal.
  - The Certificate of Purple Heart.
  - WD AGO/Form 53-55 – Enlisted Record and Report of Separation.
  - U.S. Department of Defense Separation Documents (for officers).
  - Purple Heart Life Member Card (Gold in color).
- U.S. Army Special Forces** – Provide one of the following as proof that you are an honorably discharged veteran and Special Forces qualified:
- DD214 with Special Number/Title box containing SQI identifier “3” in the prefix or suffix; a “5G” or “S,” or a CMF or Functional Area number beginning with “18.”
  - DD214 recognizing an award of “Special Forces Tab,” or “Special Forces Training” (SFQC).
  - DD214 and USAJFKSWCS retroactive award of the Special Forces Qualification Tab.
- 1st Marine Division** – Provide one of the following as proof that you are an honorably discharged veteran or on active duty and a member of, assigned to, attached to or in support of the 1st Marine Division:
- DD214/DD215 or Notice of Separation showing service with the 1st Marine Division.
  - 1st Marine Division Association Member or Life Member card showing veteran’s name.
- Gold Star Family** – Certify that you are a parent, sibling, spouse or dependent of a person who was killed in action during an armed conflict while serving in the Armed Forces of the United States.

I certify that I am aware of the eligibility requirements to obtain the group plates I have checked above and that I meet those requirements. I understand it is a crime, under ORS 803.375 and 803.385, to knowingly make any false affidavit or false statement relating to the registration of vehicles. This offense is a Class A misdemeanor and is punishable by a jail sentence of up to one year, a fine of up to \$6,250, or both.
