- The show organizer shall submit an application for a recreational (RV) show certificate to the address above, no sooner than 60 days before the first day of the proposed show, and not later than 30 days before the first day of the proposed show.
- The show must include **two or more** RV dealers, one with its main business location more than 50 miles from the site of the show. **At least one box must be checked in the dealership information below indicating the RV show is more than 50 miles from a dealer's main business location.**
- If the public is charged an admission fee, the application must include that information.
- Certificate application may be amended to add or delete RV show participant, or to correct information if submitted to the DMV Business Licensing Unit no later than 30 days before the date of a proposed RV show. If a participant identified on an RV show certificate is unable to attend or withdraws from the show after the 30th day, draw a line on the approved RV show certificate with black ink through the name of that participant.
- DMV will issue an RV show certificate to the organizer, authorizing the listed dealers to participate in the RV show if the application is complete and all requirements are met. The RV show certificate must be conspicuously posted at the main entrance to the RV show for each day of the show and shall be available for inspection by DMV.
