BOARD ACTION REPORT
February 15, 2013

The information contained in this report summarizes new, interim, and final actions taken by the Oregon Medical Board between January 16, 2013 and February 15, 2013.

On January 24, 2013, the Board issued an Order of License Suspension to immediately suspend Licensee's podiatric license due to his failure to pay child support. Automatic suspension is required by ORS 25.750.

***Beckmann, Brooke Robert, DPM; DP00434; Salem, OR**

On February 4, 2013, the Board issued an Order Terminating Order of License Suspension. This Order terminates Licensee's January 24, 2013, Order of License Suspension.

***Bray, Thomas Harry, MD; MD26593; Portland, OR**

On February 7, 2013, the Board issued an Order of License Suspension to immediately suspend licensee's medical license due to his incarceration in a penal institution. Automatic suspension is required by ORS 677.225.

***O'Gara, Michael Thomas, DO; DO08605; Gold Beach, OR**

On February 7, 2013, the Board issued an Order Terminating Amended Interim Stipulated Order. This Order terminates Licensee's November 1, 2011, Amended Interim Stipulated Order.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers, including podiatrists, in the state of Oregon. Brooke Robert Beckmann, DPM (Licensee) is a licensed podiatric physician in the state of Oregon.

2.

On January 22, 2013, the Board received information from The Oregon Department of Justice Child Support Program that Licensee is not in compliance with an agreement entered into with the Child Support Program. As a result, Licensee's license to practice podiatric medicine is subject to suspension pursuant to ORS 25.750.

3.

The Board therefore suspends Licensee's license to practice podiatric medicine without further hearing, effective immediately, pursuant to ORS 25.780.

On January 24, 2013, the Oregon Medical Board (Board) issued an Order of License Suspension regarding Brooke Robert Beckmann, DPM (Licensee). This Order was issued pursuant to ORS 25.750, and Licensee's failure to pay child support. On February 4, 2013, the Board received notification from the Oregon Department of Justice informing the Board that Licensee is now in compliance with his child support payments and that his license should be reinstated.

2.

The Board does hereby terminate the January 24, 2013 Order of License Suspension, effective the date this Order is signed by the Board Chair and orders that Licensee's license be returned to active status.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers, including physicians, in the state of Oregon. Thomas Harry Bray, MD (Licensee) is a licensed physician in the state of Oregon.

2.

On March 29, 2011, the Board issued an Interim Stipulated Order in which Licensee agreed to withdraw from active practice pending the conclusion of a Board investigation regarding allegations of criminal charges of sexual assault. On July 30, 2012, Licensee was convicted in a non-jury trial in Deschutes County on multiple criminal charges, to include two counts of Rape in the First Degree (Class A felony), two counts of Sodomy (Class A felony) and one count of Fourth Degree Assault and one count of Strangulation (Class A misdemeanors). Licensee was sentenced to 25 years of confinement by the Oregon Department of Corrections, as well as to fines and restitution.

3.

ORS 677.225(1)(b) provides that a licensee's medical license is suspended automatically if the licensee is an inmate in a penal institution.

The license of Licensee to practice medicine is suspended, pursuant to ORS 677.225(1)(b). This suspension will remain in effect until Licensee presents satisfactory evidence to the Board that Licensee is no longer incarcerated and the Board is satisfied with due regard to the public interest that License's privilege to practice medicine may be restored.
