<p>Board President Bonnie Kostecky opened a discussion regarding a Family Nurse Practitioner (FNP) licensee who applied for a second NP license (certificate) as a PNP-PC. Ms. Kostecky explained that the case is unique to OSBN due to several aspects including the applicant's existing licensure as an FNP, her education that allowed her to become dually certified as both FNP and PNP, obtaining and maintaining national certification as PNP since 1995, and her current practice with the pediatric population. The Board was asked for direction based on the challenge of the licensee's application pertaining to language in OAR 851-040-0004 which requires new applicants to complete a NP re-entry program. There was Board discussion and direction; based on the complexity of the issue, the direction was that the case be brought back before the Board at the September Board meeting for further discussion and a decision by the Board to either grant the second NP license (certificate) or require the licensee to complete a re-entry program in order to obtain a license (certificate) as an Oregon PNP.</p>
