Dr. DeBess called the meeting to order and took roll.

The Board reviewed the following rules and heard public comments.

OAR 875-005-0005 - Definitions

OAR 875-010-0031/50/65 - Permits and Licenses (Interns, Managing Veterinarian, Supervision of Interns, (License Renewals)

OAR 875-015-0030 - Minimum Standards (Medical Records, Specialty, Euthanasia)

OAR 875-015-0050 - Veterinary Dentistry

OAR 875-030-0050 - Limitations on non-CVT Duties

The Board tabled discussion of Facility Registration matters pending convening a Task Group pursuant to ORS 686.210. The Board will move forward with rule amendments relating to defining levels of supervision and 'herd or flock'; modifying intern requirements; repealing late license renewal options; and clarifying CVT scope of work for dental procedures and euthanasia.

Dr. Mark McConnell and Dr. Jon Bett gave the Board updates on AAHA wellness program activities and the International Council for Veterinary Assessment, respectively.

Dr. Hamilton moved, Ms. Pate seconded and the Board voted unanimously to:

- 1) Not issue a notice of intent to impose a disciplinary sanction for cases 17-0010; 17-0030.
- 2) Issue a notice of intent to impose a disciplinary sanction with civil penalties for case 17-0031.
- 3) Rescind Stipulated Agreement and Order for case 16-0039.
- 4) Modify citations in the Stipulated Agreement for case 17-0025
- 5) Reinstate the license of John M. Krieger, DVM (case 18-0005).

Next meetings: April 28, 2018 (Portland); July 21, 2018 (Bend); October 6, 2018 (Portland).
