# **Welcome and Introduction**

Chair Debby Jones started the meeting with reading the prevention definition, welcomed everyone and called the roll.

# Alcohol and Drug Policy Commission Director's Update

Annaliese Dolph provided a director's updates on commission-level activities and coordination across committees:

- ADPC is working on policy statements for revenue and budget priorities – the full commission will review in the October meeting.
- Regulated Substances Committee is finalizing strategies that will be incorporated in both Prevention and Harm Reduction Strategies.
- ADPC staff are continuing to work on Workforce Strategies and other Infrastructure Buckets.

# Review of Community Engagement and Draft Dashboard

The group reviewed the initial draft report of ADPC community engagement efforts over the summer:

- Communities consistently report underfunding of prevention programs, particularly within schools.
- Desire for culturally specific programming and locally driven strategies.
- Recognition that prevention is often siloed; committee members highlighted need for regional infrastructure and coordination.
- Equity and cultural responsiveness identified as cross-cutting themes.
- Importance of leveraging allied organizations (youth-serving, family services, cultural organizations) to build protective factors.

# Review of Draft Strategy Dashboard:

The group reviewed the Prevention Committee draft strategy dashboard. The committee discussed comprehensive planning priorities, reflecting on

how prevention strategies can be embedded within the broader behavioral health system.

- Emphasis was placed on ensuring prevention is considered the 'foundation' of the system, not an add-on
- Members reflected on challenges of sustaining prevention work through consistent funding streams
- Consideration of equity and cultural responsiveness was highlighted as a cross-cutting theme.

# SCHOOLS AND YOUTH NEEDS

- Schools viewed as critical prevention partners, though they remain under-resourced.
- Committee acknowledged the importance of creating regionally equitable access to these resources.

# REGIONALIZATION AND INFRASTRUCTURE

- Prevention services need stronger infrastructure across counties.
- Suggestions included designating prevention coordinators in every county to guide and support work.
- Committee expressed support for one-stop shops for prevention.
- Emphasis on sustainability, equitable access, and integrating prevention into broader community health planning.

# REGULATED SUBSTANCES

- The ADPC established a Regulated Substances work group to review alcohol and cannabis.
- Committee noted this group's work will influence prevention strategies once recommendations are finalized.
- Highlighted the need for stronger alignment between regulated substances policy and prevention goals.

# CHALLENGES AND BARRIERS

- Inconsistent funding streams and staff shortages hinder sustainability of prevention programs
- Data gaps, particularly at the county level, make it difficult to measure prevention effectiveness
- Prevention is often overshadowed by treatment and recovery in funding priorities.
  - Need for better technical assistance and coordination across regions.
