### Key Takeaways

### Summary By Topics

#### New Security Measures

- Implemented muting and video restrictions at start of meeting due to recent disruptive incident
- Participants unable to unmute or turn on video until verified by hosts
- Aimed to balance security needs with maintaining open public meeting

#### Pilot comprehensive regional school treatment and recovery programs

- Embed cross-trained professionals providing evidence-based, culturally responsive outpatient services
- Establish policies to defer from detention/punitive approaches
- Build in Medicaid billing, disability support, family navigation services
- Ensure every Education Service District has access to a recovery school or on-campus peer-based recovery program
- Change school substance use policies and plans
- Adjust existing discipline policies, remove/change expulsion policies, implement more treatment interventions vs.

punishments

- Provide individualized interventions considering each student's unique situation
- Protect confidentiality of students in treatment/services
- Carefully consider when/how to involve parents vs. connecting students with other trusted adults
- Conduct more thorough, equitable investigations of reported incidents

#### Legal/Carceral Setting Ideas

- Expand treatment, recovery, and training offerings at Oregon Youth Authority facilities
- Fill certified counselor positions to implement ASAM criteria
- Develop gender/age/culturally responsive curriculum
- Expand medication access and education
- Increase tablet access for recovery education and telehealth
- Pilot transition program connecting youth to culturally-specific peer/family navigation
- Support county juvenile departments to provide diversion programs and direct SUD/co-occurring supports

### Chronological Summary

**New security protocols introduced @ 12:07** - Jummy and Wes explain that new security protocols are being implemented in response to a recent disruptive incident in a public meeting. At the start of the meeting, participants will not be able to turn on their audio or video until they are verified. Once verified, participants' video will be turned on but they will remain muted until the meeting begins.

**Group agreements and icebreaker @ 17:41** - Kaleb reviews the group agreements, emphasizing the importance of being present, respecting confidentiality, and allowing space for quieter voices. Kamryn then leads an icebreaker where participants share their preference for the "perfect banana" in the chat.

**Reviewing and expanding on big ideas @ 29:10** - Jummy and Wes walk through the two big ideas that were previously discussed - one focused on expanding treatment, recovery, and training offerings at the Oregon Youth Authority, and another on supporting county juvenile departments to provide diversion programs. The group provides feedback and suggestions for adding more detail and context to these ideas.

**Breakout group discussions @ 42:38** - The group splits into two breakout groups - one focused on education and the other on legal/carceral settings. They dive deeper into the big ideas, discussing specific policy changes, the role of families and trusted adults, and the need for more trauma-informed and restorative approaches.

**Recap and next steps @ 1:59:16** - Kaleb provides a recap of the key themes discussed, including the importance of supporting youth both before and after disciplinary incidents. Wes shares information about the next meeting and the upcoming Policy Corner session.
