

### 9.24.25 ADPC PREVENTION SUBCOMMITTEE RECAP NOTES:

#### Welcome and Introduction

Chair Debby Jones started the meeting with reading the prevention definition, welcomed everyone and called the roll.

#### Alcohol and Drug Policy Commission Director's Update

Annaliese Dolph provided a director's updates on commission-level activities and coordination across committees:

- Next steps on after committee approval of dashboards:
  - o ADPC Commission vote on the committee approved dashboards in November
  - o Move to the Governor's Office for approval.
  - o High Level Plan will inform detailed work plans for 2026 and 2027.
- Theme and Messaging:
  - o Plan titled "Opening Doors: Access, Belonging & Connection Across Oregon."
  - o Running a cover art contest (winner gets credit & one state substance use-related conference covered).
- October Road Shows:
  - o Two weeks (Oct 6 & Oct 13), eight statewide locations.
  - o Goal: show community representation and gain buy-in.

- Encouraged all committee members to register & attend; links emailed.
- November Commission Meeting: Strongly encouraged attendance to demonstrate committee support.

## **Prevention Dashboard – Final Review & Key Points Discussed:**

### Terminology:

- Broad discussion of “substance use” vs “misuse.”
- Consensus: keep “use” in the dashboard for clarity/consistency but note “misuse” nuance in future work plans & public-facing docs.
- Some members suggested “use/misuse” combo in areas like college settings and prescription drug misuse.

### Agency Role Clarity:

- “Support OLCC” wording debated — members want consistency where ADPC recommends/supports but may not always align with OLCC’s current stance.
- Agreement to refine language consistency (“support policies,” “partner with OLCC,” etc.).

### Lead Organization Column:

- ADPC listed for most strategies — intentional as plan owner.
- Future work will identify additional state partners (e.g., OLCC, ODE).

### K-12 Education Strategies:

- Acknowledge school workload limits; aim to support rather than burden schools.
- Importance of collaboration and not placing full prevention responsibility on educators.

### College/University Prevention:

- Engagement confirmed with OCUSP and collegiate prevention specialists.
- Alignment with suicide prevention efforts.
- Suggestion to explicitly include misuse language and broaden beyond 4-year universities to tech/community colleges.

### Community-Based Prevention:

- Debate over phrasing (“education & pro-social activities” vs broader prevention strategies).
- Intent is to meet organizations where they are and expand capacity without overwhelming them.
- Will revisit wording during work plan phase if too narrow.

### Edits Already Planned:

- Change all “substance misuse” references → “substance use” in dashboard draft.

- Consider use & misuse combo in collegiate and prescription contexts.
- Adjust support/partner language for consistency.
- Minor fixes (typos, “transition-aged youth/young adults” clarity).

## **Public Comment**

- No objections to plan direction; supportive remarks from commissioners and community members (e.g., Moxie, Tony).
- Feedback reinforced supporting schools without adding burden, ensuring collaborative partnerships, and respecting local control.

## **Votes and Next Steps**

### **Vote:**

- Committee unanimously consented to move dashboard forward with adjustments.

### **Next Steps:**

- ADPC staff & Third Horizon will finalize edits based on this discussion.
- ADPC staff will prep for:
  - o October Road Shows (member participation encouraged).
  - o November Commission vote — members urged to attend for visible support.
  - o After Commission approval → detailed work plans built Dec–Jan; committees reconvene early 2026.
