#### Mission

The Addictions & Mental Health Division (AMH) assists Oregonians and their families to become independent, healthy and safe by:

- Promoting resilience and recovery through culturally competent, integrated, evidence-based treatments of addictions, pathological gambling, mental illness, and emotional disorders, and
- Preventing and reducing the negative effects of alcohol, other drugs, gambling addiction, and mental health disorders.

## Memory Lane cont.


- Supported a variety of Parenting Programs.

# Memory Lane cont.

- Synar Program requiring states to reduce teen use of tobacco.
- Provided County Profiles for Counties.
- Minimum Data Set.
- Prevention Certification Specialist process utilizing International Certification Reciprocity Consortium standardized format and processes required for Prevention Coordinators.

## Memory Lane cont.

- Evaluation, Research and Technology (PERT).
- Institute of Medicine is part of the planning process for County/Tribal annual plans.
- Interagency Technical Assistance Teams provided statewide training on Cultural Competency/Gender Specific and Best Practices/Evaluation.






## Shift

## Circle of Prevention: A Comprehensive Approach







- Based on Prevention O.A.R.
- Data collection on MDS was reported.
- Prevention Certification required.
- Site reviewed with Letter of Approval
