### **Temporary Oregon Administrative Rule**

In June of 2021, the Legislature gave ODA approval to do 50 year leases (HB 2434 and 3055). Board must adopt a concurrent OAR.

Consider Adoption of temporary administrative rule:

OAR 738-015.0020 (3) currently states "The base term for commercial aeronautical leases shall be no longer than twenty-five (25) years" and (4) states "If Lessee requests a renewal, the Department may agree to renew the lease, consistent with this rule, for one (1) five-year period, provided the total lease period does not exceed thirty (30) years."

Proposed amendment – (3) " The base term for commercial aeronautical leases shall be no longer than **forty-five (45)** years" and (4) If Lessee request a renewal, the Department may agree to renew the lease, consistent with this rule, for one (1) five-year period, provided the total lease period does not exceed **fifty (50) years**."

This temporary rule shall be in effect upon adoption, and for no more than 180 days from time of adoption.

### Federal funds FFY21

- For FFY21, OR airports received grants totaling about \$324M
  - \$56.5M AIP (regular and
    - discretionary)
  - \$140M CARES
  - \$31.9M CRSSA
  - \$95.5M ARPA
- 97% of CARES, CRSSA, ARPA funds went to commercial service airports
- 3% went to GA airports





## **FEMA grant application**

- \$1.5M grant request through FEMA's Hazard Mitigation assistance Program
- 25% local match
- Follow-up study to RRAP report
- Looks at most of the 97 publicuse airports, their roles following a major seismic event, needs, costs, implementation, tool for non-aviation decision makers and first responders (i.e. which airports can accept a C-130, etc.





#### **Connect Oregon is back**

- ODOT Grant program
- \$477M for 285 projects so far
- 66 aviation projects

   (63 airports, 3 other)
   largest \$7.5M Redmond,
   smallest \$16K each to
   Lexington and John Day)
- \$46M available for aviation, marine and rail only
- 30% local match
- 4 ODA airports applying
- Applications due Oct. 29th
