Program Management

Tall Structure Reviews/ 7460-1 Analysis / Land Use Analysis:

ODA, mainly Seth Thompson has been busy reviewing record numbers of land use and tall structure requests. We are on track to increase our reviews by 30% compared to last year. We have seen a substantial increase in new development and construction over the past year. We are also busy getting to know the new FAA tall structure review software and process that they rolled out last month.

We will provide an in depth Rulemaking timeline to the Board in December regarding the legislation allowing ODA to collect fees for the associated review and analysis that is performed by ODA. This timeline will include the committee and meetings process.


ODA / ODOE Reviewing Agency Coordination:

ODA -Business Oregon / UAS Test Range Partnership

ODA sponsored this years Booth at the Atlanta UAS / Xponential. ODA paid for additional travel costs and booth furnishings with the final monies in the Biz Oregon/SOAR UAS transfer account.

- Conference was August 16-18th in Atlanta, GA.
- We are awaiting final information regarding total conference numbers and leads.
- Pendleton UAS is saying that while attendance was down 50%-60% and exhibitors aprox. 30%- 40%, their actual qualified beneficial leads are up over all years past and are hopeful to get additional clients from those leads.

- ODA's PMP Program =
- Cost avoidance by performing maintenance \$0.617 per yard, or 23.8%
 - This amounts to \$50 million in cost avoidance due to pavement maintenance inputs over the 10 year study life.

- Siletz Bay Runway Rehabilitation Project Design kick off is next week
- Chiloquin State Airport Obstruction Removal Design (Phase 1)

Percent Complete – 30% - Current - Obstruction Removal Preliminary Plans / Next items - On hold until obstructions and property are surveyed

Chiloquin State Airport - Obstruction Removal – Predesign/Survey (Phase 2)

Percent Complete – 0% - Current - CWEC awaiting signed WOC / Next items - Property Owner Outreach and Contact & Obstruction and Property Survey, County Surveyor Exhibits and Coordination & Property Appraisals and Easement Acquisition

Cottage Grove State Airport – Fencing Project – Construction - Ongoing

Percent Complete – 30% / Current - Construction to begin October 18th/ 90-day construction period

Independence State Airport – Fencing Project – Construction Ongoing

Percent Complete - 30% / Current - Construction to begin End of October. 90-day construction period

Mulino State Airport – Obstruction Removal – Design/Survey (Phase 1)

Percent Complete – 10% / Current – Property Owner Outreach and Contact / Next items - Obstruction and Property Survey (next 2 weeks) - County Surveyor Exhibits and Coordination (Nov- Jan 2022) - Property Appraisals and Easement Acquisition (Begin Nov 2021)

Joseph State Airport

Final Draft in process and being revised to address FAA comments.

ODA will submit to FAA for final review and acceptance later this month. FAA Review may take up to 90 days.



Aurora State Airport

- PAC has been confirmed by all PAC participants
- Master Plan Kick off is scheduled for November 16th, 2021. Notice will be published in the newspaper next week. All electronic notices & gov delivery to interested parties will go out next week.



Connect Oregon - Update

- ConnectOregon Coordination with ODOT is being scheduled. Full timeline will be discussed in the December Board meeting along with specific Board related training for Modal Committee review requirements. The Aviation Board will serve as the official Modal review committee as past ConnectOregon programs. ODA anticipates a formal Modal Review Board meeting in March 2022. The meeting will be Hybrid
 - Key Dates for the Board:

Modal/ACT/RST Review – January-March 2022

Final Review Committee - April 2022

Connect Oregon funds "transportation projects" which per statute means a project or undertaking for rail, marine or aviation capital infrastructure, including bridges, or a project that facilitates the transportation of materials, animals or people. This does not include maintenance, ongoing operations, or planning efforts that do not result in construction

Connect Oregon Projects shall contain the following deliverables:

- Industrial or employments connections
- Linking workers to jobs
- Measurement of Success (Improved use and efficiency)
- Safety
- Transportation Connections
- Serving Business Clusters

- ODA has incorporated a new electronic procurement and bidding system that is an inclusive system where all procurements and contracts will be housed statewide. This process took an 24 month implementation and is now up and running.
- ODA has also posted 3 RFP's for Planning and Engineering services for some of our NPIAS airports. These procurements take place every 5 years and are airports specific. Proposals are Due in November. A full update is expected at the December Board meeting.
- Daily Huddle meetings continue to take place <u>every day</u> with Admin and Planning (45 minutes to 1 hr) and we take this time to round robin and problem solve across business lines
