

Civil Penalties and Rules Governing Safe and Orderly Use of Airports

Need and Justification

- Rules are needed to ensure a safe and controlled aircraft operations area at the Aurora State Airport (UAO), by providing the Department of Aviation (Department) the means to enforce rules against Vehicle/Pedestrian Deviations (V/PD).
- ORS 836 grants authority for the controlling officials, subject to Aviation Board approval, to make rules promoting the safe and orderly use of their airports, and issue civil penalties for violations of such rules.

Proposed Adoptions to OAR Chapter 738-140

- A civil penalty may be imposed for Vehicle/Pedestrian Deviations committed at an airport operated by the Department that has an air traffic control tower.
- For each occurrence of a V/PD, the Department may impose a civil penalty of \$2,500 on the person or non-pilot who committed the V/PD.

Summary of Proposed Revisions to OAR Chapter 738

<u>738-140-0010</u> Definitions

(11) "Vehicle/Pedestrian Deviation" ("V/PD") means any entry or movement on the Movement Area by a vehicle (including aircraft operated by non- pilots) or pedestrian that has not been authorized by air traffic control.

(12) "Movement Area" means the runways, taxiways, and other areas of an airport that aircraft use for taxiing, takeoff, and landing, exclusive of loading ramps and parking areas, and that are under the control of an air traffic control tower.

Violations for Which a Civil Penalty May be Imposed

(9) A Vehicle/Pedestrian Deviation committed at an airport operated by the Department that has an air traffic control tower.

Formula to Determine Amount of Civil Penalties for Violations of Chapter 837

(1) For each occurrence of a V/PD in violation of OAR 738-140-0020 (9), the Department may impose a civil penalty of \$2,500 on the person or non-pilot who committed the V/PD.

(2) For all other violations of this Chapter, the civil penalty shall be determined according to the formula set forth in Formula to Determine Amount of civil Penalty for Violations of Chapter 837.
