- Bandon State Airport
 - PMP – Taxiway and Apron closures
 - Now through Thursday, 7AM to 5PM daily

Aurora State Airport – Gate Update

- New gate key pads installed at Blue and Purple (ODAV owned/operated) gates
 - Add phone calling functionality for business access inside the fence
- Gate closure will go into effect in late August
 - More information will follow for airport users in email and paper mail



Project Updates

- Independence State Airport – Fence Project
 - East side fence is complete
 - West side construction will resume early September
- Aurora State Airport – Surface Seal and Markings Project
 - 2 Open House meetings completed, phasing finalized
 - Completing design, planning fall construction weather permitting
- Toledo Apron Reconstruction Project
 - Bids received August 2nd, contracting for construction this summer/fall
 - 3-4 weeks of apron/taxiway closure expected

Project Updates – Obstruction Removal

 - EA Rewrite – FAA requested additional information, updating all chapters and will resubmit
- Mulino State Airport
 - Survey ongoing
 - Planning for trees with easements/on our property to be removed after nesting season this fall

 - Survey pending completion at Mulino



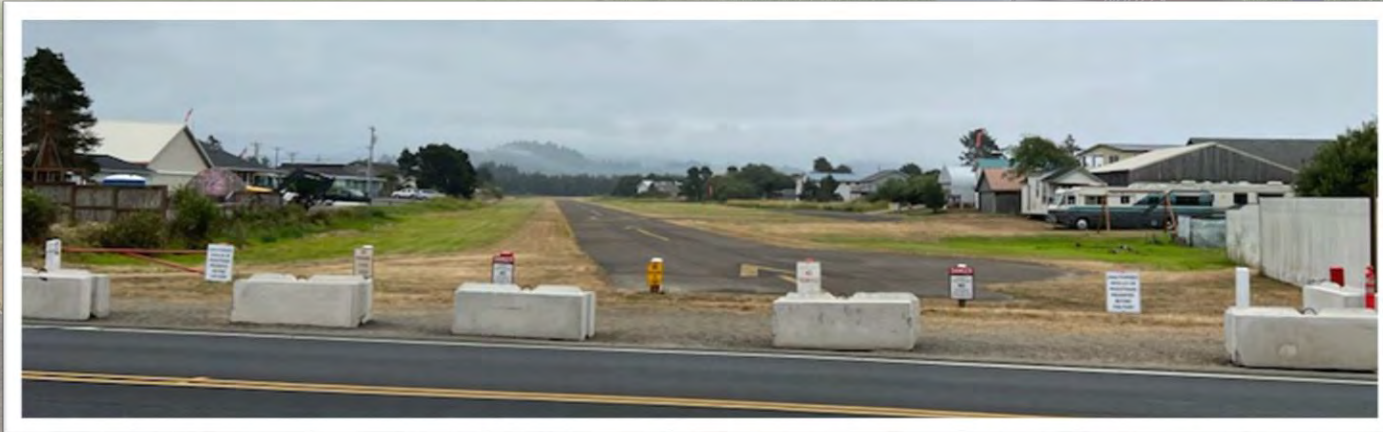
