 - Appraisals and easement acquisition will begin after EA is complete
- Mulino State Airport
 - Survey completed, beginning pre-work for appraisals and easements
 - Trees with easements/on our property went out to bid, rejected bids due to cost. Will rebid and aim to start construction Oct. 1st
- Chiloquin State Airport
 - Survey ongoing


- Aurora State Airport Surface Seal and Markings Project




- Aurora State Airport ATCT Seal / Preventative Maintenance

 - Construction in spring/summer of 2023




- Aurora State Airport Surface Seal and Markings Project
