Top Ten Things You Need to Know to Apply for a COAR Grant

1. Get a log in and make sure you have access to the documents in e-grants
2. Keep the grant coordinator emails and phone numbers handy – When in doubt, ASK US! We’ve been through this process 😊
3. Get the application done EARLY
4. If this is for an AIP grant, be sure you have that grant; the application is only for that grant
5. Be sure you have the Matching funds clearly identified and budgeted
6. Read the Instructions for Applicants (so you can maximize your points)
7. Read the Instructions for Reviewers (so you know what they are looking for when scoring)
8. When filling out the application, SAVE often to be sure you don’t lose data!
9. The system will time out after 2 hours, so just log back in. Do NOT start another application!
10. Be SPECIFIC with your details. “See Master Plan” is too general. Copy paste the quote from the Master Plan – priceless.

And most of all, Apply! You get 100% of what you don’t ask for!

The Aviation System Action Program (ASAP) was created by the Oregon State Legislature in HB 2075 (2015) to invest in Oregon's public use airports statewide. The Legislature made the program permanent in 2021 (HB 2434) thus the fuel tax of two cents per gallon of Aviation Gas and Jet Fuel will continue to provide funds for grants.

The Critical Oregon Airport Relief (COAR) program provides grants in the following three areas:

- 1 To assist airports in Oregon with match requirements for Federal Aviation Administration (FAA) Airport Improvement Program grants.
- 2 To make grants for emergency preparedness and infrastructure projects, in accordance with the Oregon Resilience Plan.
- 3 To make grants for aviation related economic development.

The Aviation System Action Program (ASAP) is funded through Jet Fuel and Aviation Gas taxes of two cents per gallon. Every dollar is being leveraged through matching grants, resiliency preparedness, economic opportunity, and infrastructure development across Oregon.

COAR works!! And, thanks to the support and great projects our airport sponsors have delivered statewide, the Legislature passed and the Governor signed HB2434 to continue collecting the fuel taxes dedicated to funding this grant program for Oregon airports.
