Aviation System Action Program

The Aviation System Action Program (ASAP) fund was created as a result of House Bill 2075 in 2015, which established a temporary increase to aviation fuel tax revenue to fund grant programs administered by the Oregon Department of Aviation (ODAV) to benefit Oregon airports and aviation. The increase in fuel tax was made permanent in 2021 through House Bill 2434. ASAP consists of two grant programs, both of which have a **strong rural emphasis**.

The Critical Oregon Airport Relief (COAR) program receives 75% of the fuel tax revenue and provides grants to public use airports in Oregon in the following three areas:

•To assist airports in Oregon with match requirements for Federal Aviation Administration (FAA) Airport Improvement Program (AIP) grants

•To make grants for emergency preparedness and infrastructure projects, in accordance with the Oregon Resilience Plan

•To make grants for all public use airports for aviation related economic development

The COAR program was created specifically to provide grants to small, non-federally funded airports first, to make sure the statewide system of airports remains viable and available for all users.

The State-Owned Airports Reserve (SOAR) program receives 25% of fuel tax revenue from ASAP and provides funding for the 28 state-owned airports for safety improvements, infrastructure projects, maintenance projects, and capital improvements.

A third grant program named Rural Oregon Aviation Relief (ROAR) was created to assist commercial air service in rural Oregon. This program was closed in 2021, and funds were merged into the COAR program (HB2434).

ASAP ran its first grant cycle in 2017. That year, the COAR program awarded \$1.46 million to 24 public use airports in Oregon, the ROAR program awarded \$70,000 to one airport, and the SOAR program awarded \$1.65 million to seven state owned airports.

Since 2017, ASAP has made a significant contribution to achieving ODAV's mission to provide infrastructure, financial resources, and expertise to ensure a safe and efficient air transportation system in Oregon. ODAV continues to run grant cycles annually, and to date has awarded more than \$17 million to Oregon's public use airports through these grant programs.

The following pages outline the airports and projects where ASAP funds have been spent. The NPIAS designation refers to whether an airport is eligible for federal funding for capital projects.
